IN WAS DRIVING FROM SHOWROOM TO DESIGNATED AREA (WHEELER'S ESTATE) TO DELIVER TO MY CLIENT AS HE HAS BOOKED THIS VEHICLE FOR RENTAL. TOOK UPPER THOMSON ROAD AS MY ROUTE. AS I WAS TRAVELLING ALONG THAT ROAD, IT WAS RAINING CONSISTENTLY, SO I DECIDED TO DRIVE AT THE CENTRE LANE AT GOING THE USUAL ROAD LIMIT.
