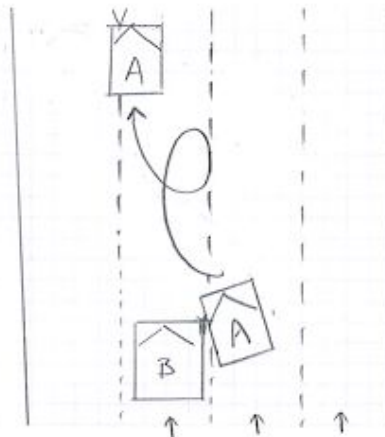

Describe Circumstances of the Accident

Accident date/time is 24/01/2023 at about 1714 HRS.

I was on BKE (Woodlands), 7km. ~~on~~ near exit 7, preparing for exit at exit 8.

Upon checking my mirrors and signalling, I made the turn to change lanes. There were no cars when I checked. Suddenly, a car hit me from the left very hard and at a very fast speed. My car skidded and spun clockwise one round before coming to a stop at the splitway of exit 7.


I was on the 2nd lane (from right), intending to shift to the 3rd lane.
