Describe Circumstances of the Accident

On the stated date & time, the petrol kiosk was empty except me. After pumping petrol, I heading over to the air pump wanting to pump air. While pumping air half way, vehicle B was seen waiting at the initial position. The 2 lots beside my car are all empty. After done pumping air, I proceeded into my car to start the engine & hit reverse gear. But I didn't move yet as I was keying in my GPS. That was when vehicle B slowly drive towards my back which is strange because there were empty lots beside my car & also knowing that I need to reverse out if not he can't take over my lot as well. But vehicle B as shown in my diagram, came to my rear & stopped there for no reason waiting for me to bang into him.

Notes - I suspect that this guy is trying to fraud insurance claim.

- The petrol kiosk CCTV capture the whole accident but they don't allow me to retrieve the footage, only allow me to view the footage.
- I had lodged a police report regarding this accident.

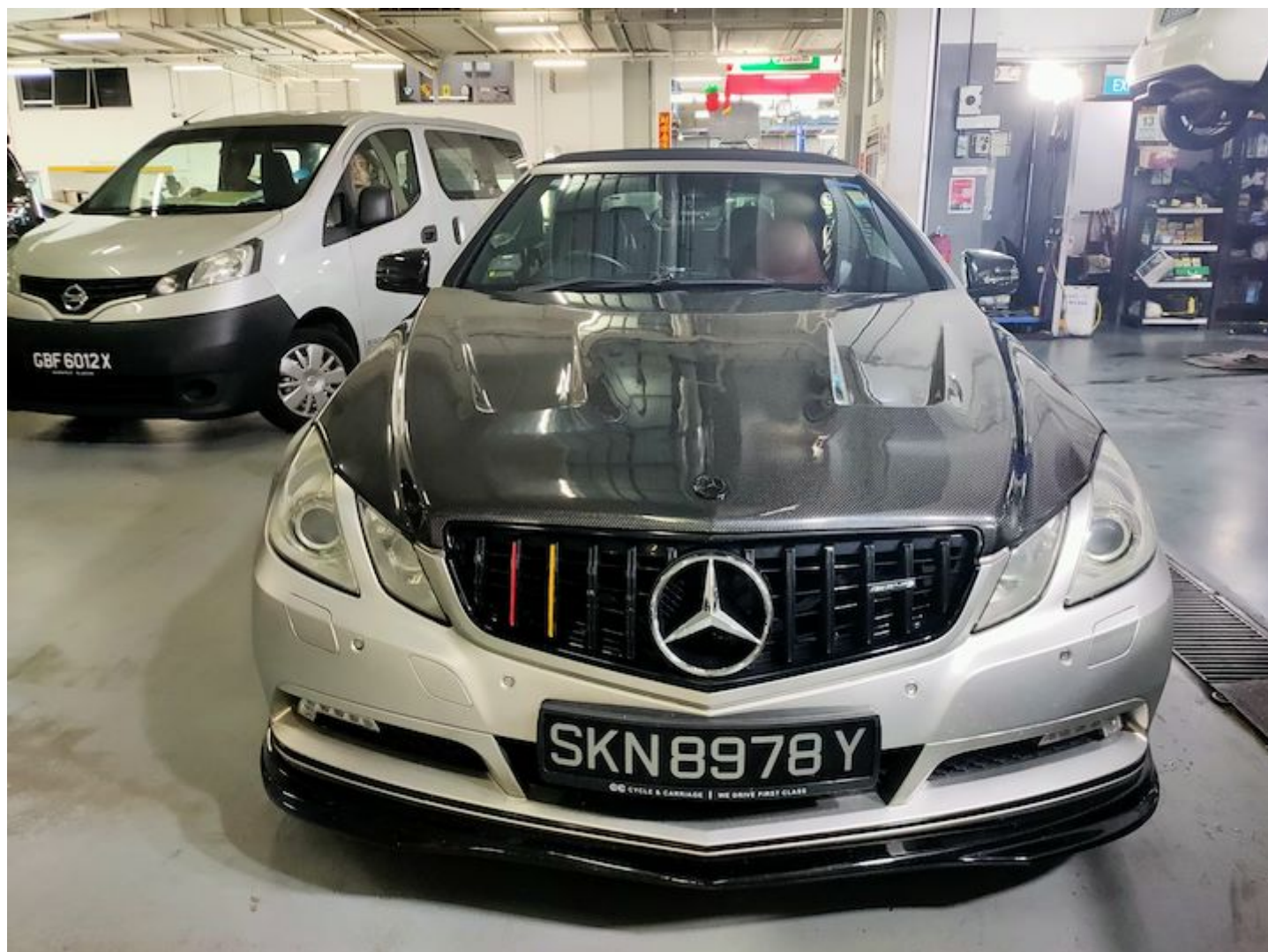

Description of Incident
