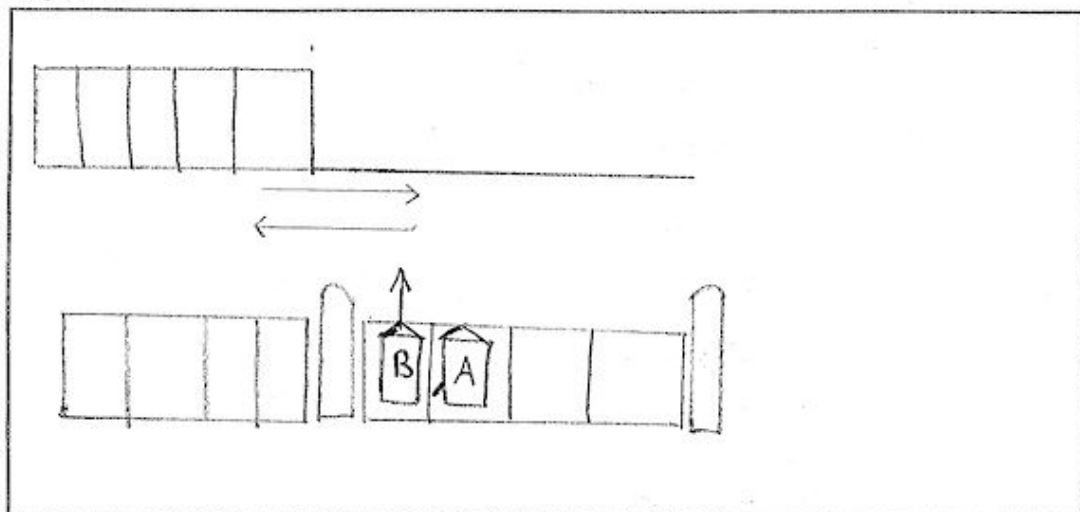

Describe Circumstances of the Accident

I was at the carpark with my wife and kid. I was looking to put my kid into my car seat. I looked around to ensure that the surrounding was safe before I opened my left rear car door to put my kid into the child seat. After I placed her into the seat and was in the midst of fastening the seat belt, a stationary car beside mine suddenly started its engine and moved off - car (B). As car (B) was moving off, my left rear car door was caught in car (B)'s right rear car door. Car (B) continued trying to move off until I started knocking on its door to alert the lady driver. The lady driver stopped the car, and together with her passenger aligned to take a look. The lady driver then reversed her car to release my door. After assessing the situation and the damages, car (B)'s passenger and I exchanged contacts. We I was initially given an option of private settlement.

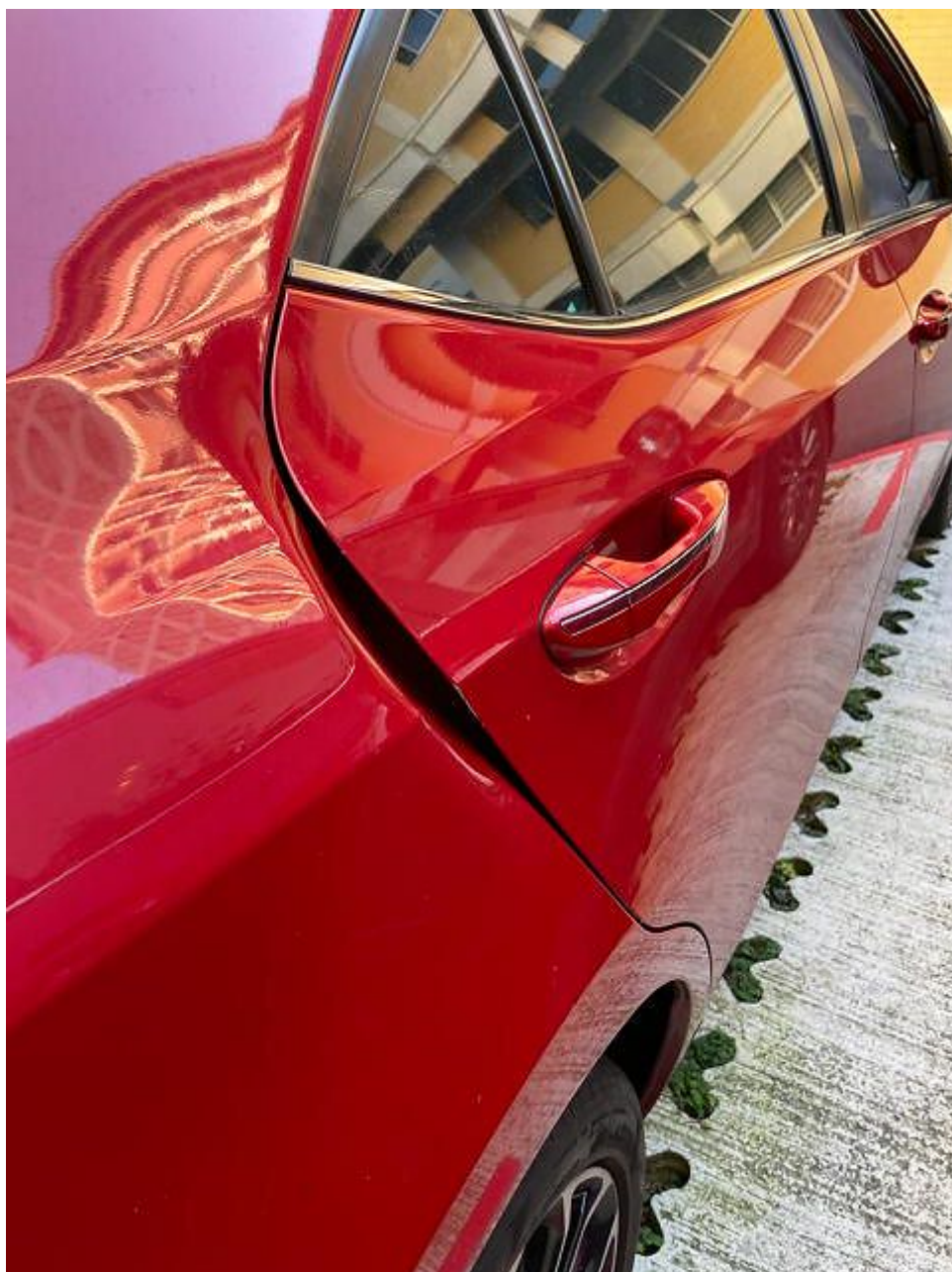

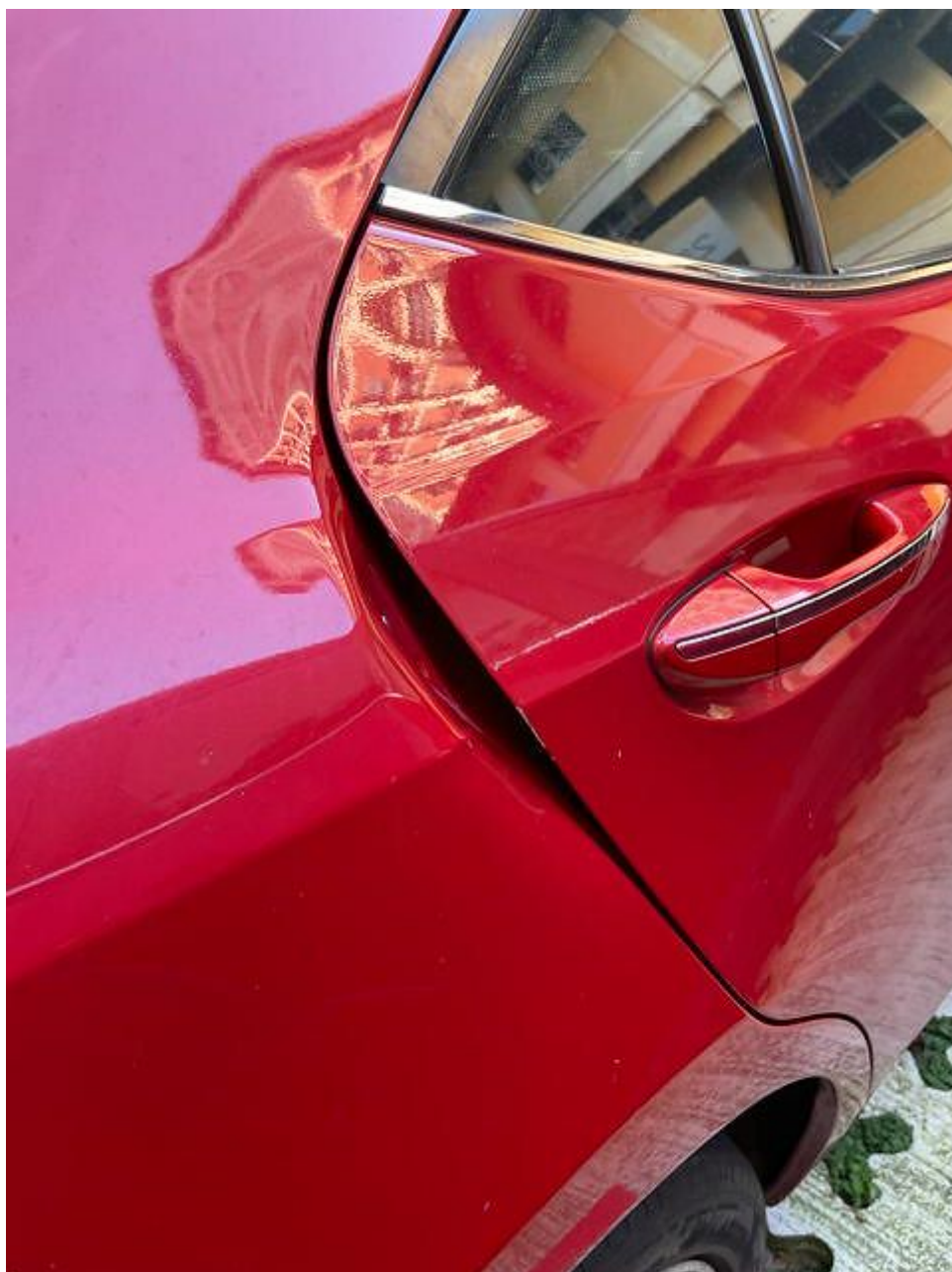
























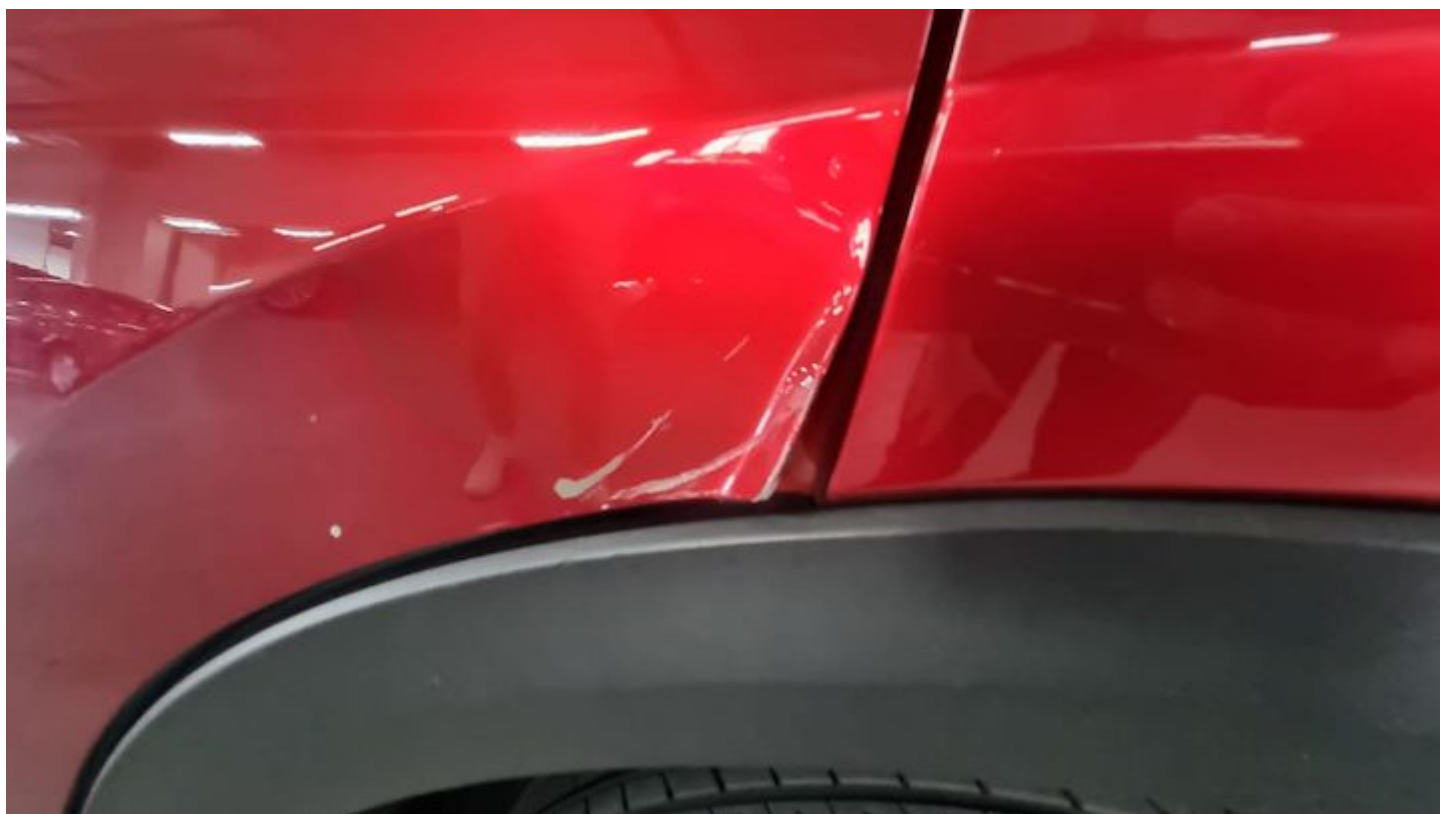
