ON 04/02/2023 AT ABOUT 1600HRS I WAS DRIVING VEHICLE A (SLQ8189E) ALONG ION ORCHARD TO PICK MY PASSENGER. AFTER PICKING UP MY PASSENGER, THE TRAFFIC FLOW INFRONT WAS STOPPED, WHILE MOVING OFF ONTO THE RIGHT LANE I SAW VEHICLE B (SND5172S) MOVING OFF TO THE RIGHT LANE AS WELL. I DID STOPPED TO ENSURE SAFETY, HOWEVER VEHICLE B DID NOT STOP IN TIME AND COLLIDED ONTO VEHICLE A FRONT RIGHT DOOR PORTION. NOBODY WAS INJURED DURING THE ACCIDENT.


