

ON 14/2/23 AT ABOUT 7.20PM WHILE AWAITING TRAFFIC LIGHT TO TURN GREEN AT SIMES AVE TOWARDS TAMPAVES AVE 5TH (MUSKATTA STE ~~IMP~~ ISMATE) WAS HIT IN THE REAR BY MY VEHICLE (SM07228K) WAS HIT AT THE REAR BY GREY MAZDA (SLC 3267U). I PROCEEDED TO EXIT THE CAR TO CHECK AND OBSERVE DAMAGES TO THE REAR OF THE VEHICLE. DRIVER OF GREY MAZDA, MR TAN YEW HUIE EXITED HIS VEHICLE AND WE BOTH EXCHANGE OUR DETAILS. AS THE TRAFFIC WAS HEAVY I WAS UNABLE TO EXCHANGE TO TAKE ROAD CONDITIONS WAS WET AND IT WAS DARKENING. INITIALLY MR TAN LISTED TO PROCEED FOR PRIVATE SETTLEMENT HOWEVER AFTER HEARING THE COST OF REPAIRS, HE CHANGED HIS MIND AND TO PROCEED TO SETTLE VIA INSURANCE.
