- 1) Gap of the right handle bar damage.
- 2) Right side mirror not in position, and can see crack marks on the mirror holder.

I ~~supp~~ suspect someone may hit my bike and bike drop on the right.

I got off the bike, look at the right side of the bike and notice the following


- 1) There are scratch marks on the right side
- 2) scratch mark on the right handle bar
- 3) the rear right ~~city~~ signal light crack and the particles are on the floor.
- 4) The pillion right foot rest crack and the partial of it is on the floor.
- 5) some additional scratch mark ~~on the~~ and crack on the right fairing.

I notice there is a dent on the rear left of the car plate.


I have lodged a police report on the same day of the incident. Brief Details.

I wanted to go work in the morning and notice that the front right mirror was not in position and crack can be seen. Suspected somebody or something may have knocked down the bike to the right side and lifted it back up. Upon looking at the other part of the bike, notice the following.

- 1) The rear right signal casing has crack into pieces and can be seen on the floor.
- 2) The foot rest for pillion crack.
- 3) Side of the right handle bar has scratch mark.
- 4) Frame sliding has scratch mark.
- 5) Grip on handle bar was compressed inwards.
- 6) Additional scratch marks seen on the fairing.
