

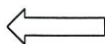

Letter of Authorisation & Indemnity





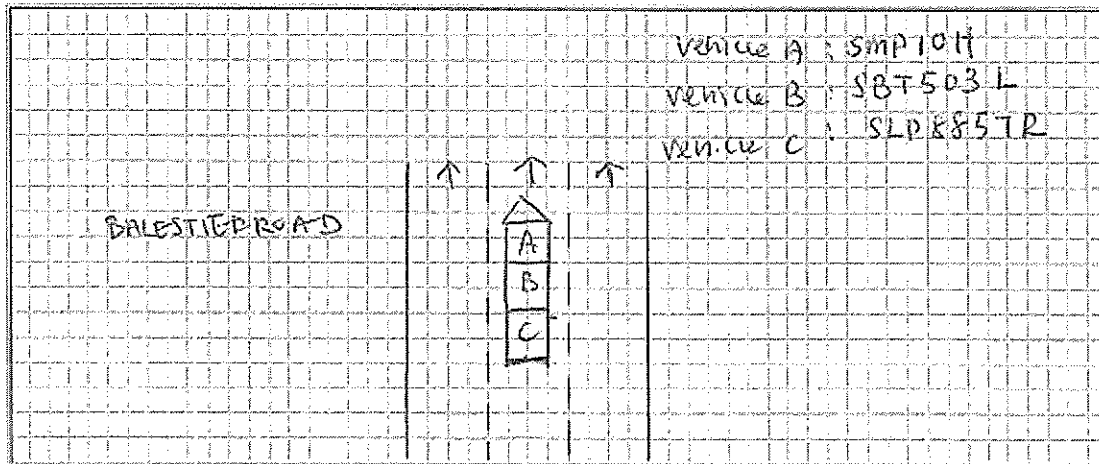

Sketch Plan







