**Brief Details.**

At around 2.09pm, I was driving a private hire car plate number SNF4397G at SLE towards mandai ave semawang with a passenger inside. I was driving in the 1st lane at the speed limit about 85-90km/h as the road flow is smooth and suddenly a Malaysia register car ahead of me met and accident with a Singapore vehicle ahead of him. I quickly managed to slow down my vehicle to avoid collision with the Malaysia vehicle ahead and suddenly the vehicle behind me, plate number SMN35Y hit hard on my rear car and the impact made my car to hit the rear vehicle of the Malaysia register car, JHG1889 ahead of me. As what I remember total of 4 cars was involved in the accident, 3 Singapore register car and 1 Malaysia register car. At about 3.10pm, Traffic police attended to the accident and took all the particulars including my sd card of my car camera.
