Brief Details.

On 18/02/2023 at about 1345hrs, I was driving my car JHG1889 along SLE(CTE), 8.6km on the first lane. Out of the sudden, the car in front of me, SML1733U made an emergency brake. I made a brake as well and managed to stop my car in time. However, I felt an impact coming from the rear of my car which caused my car to surge forward and collided onto the rear of SML1733U. I then felt another impact coming from the rear.

Subsequently, I got out of my car to make a check. I discovered that there were 5 cars involved in the accident. The first car is SLA3494R, second is SML1733U, third is my car, JHG1889, fourth car is SNF4397G, and fifth car is SMN35Y. We then decided to exchange our particulars amongst each other. However, shortly after the first car drove off. I checked with the driver of the car in front and he told me that the first car had made an emergency brake however he is unsure why exactly.

Shortly after, Traffic Police and ambulance attended to us. My passenger and I are not injured, however the people in the fourth and fifth car are injured. There is a dashcam in my car and it had recorded down the incident.
