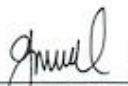

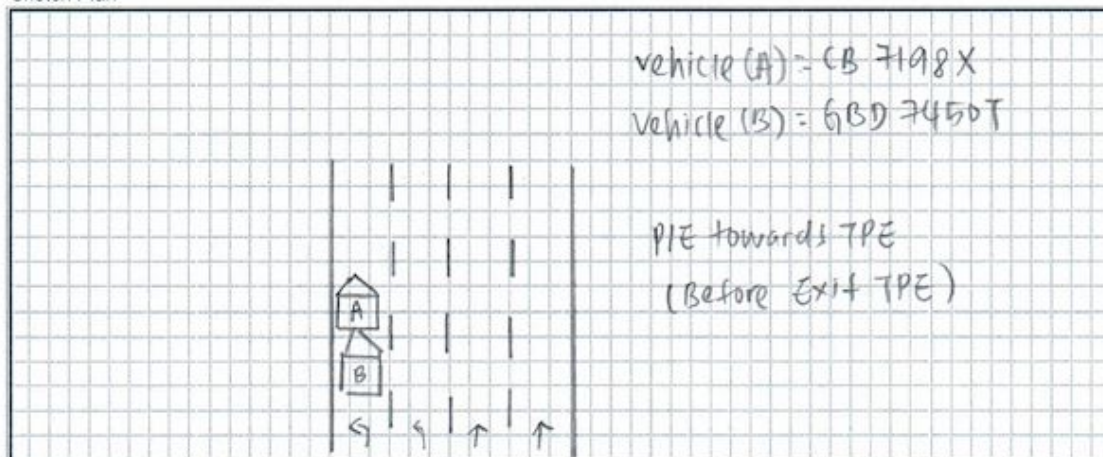

Sketch Plan

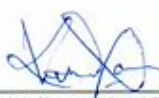


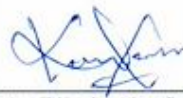
