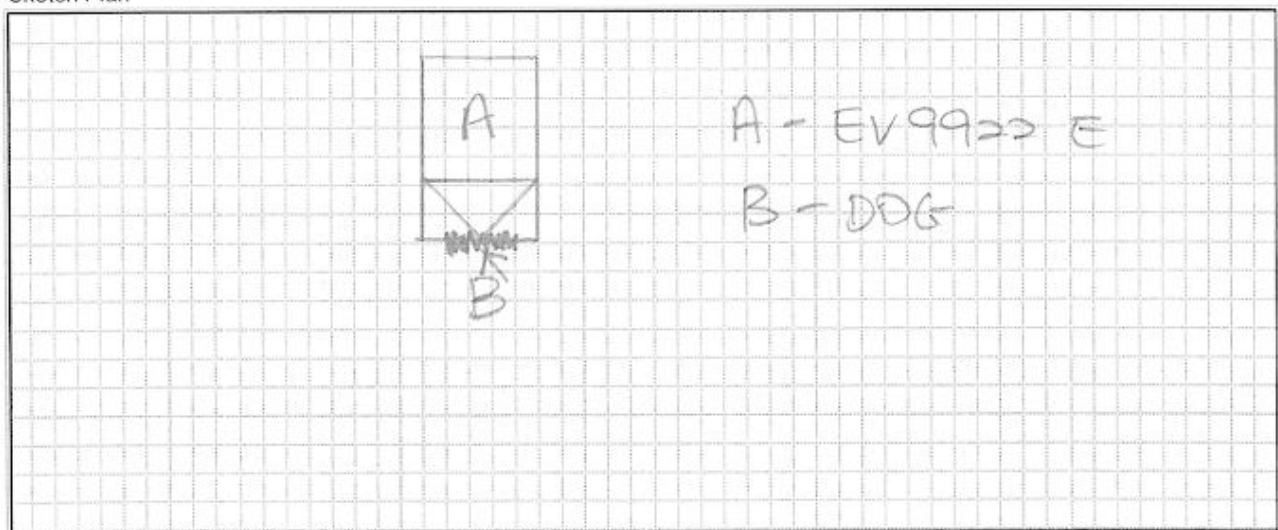

**Sketch Plan**



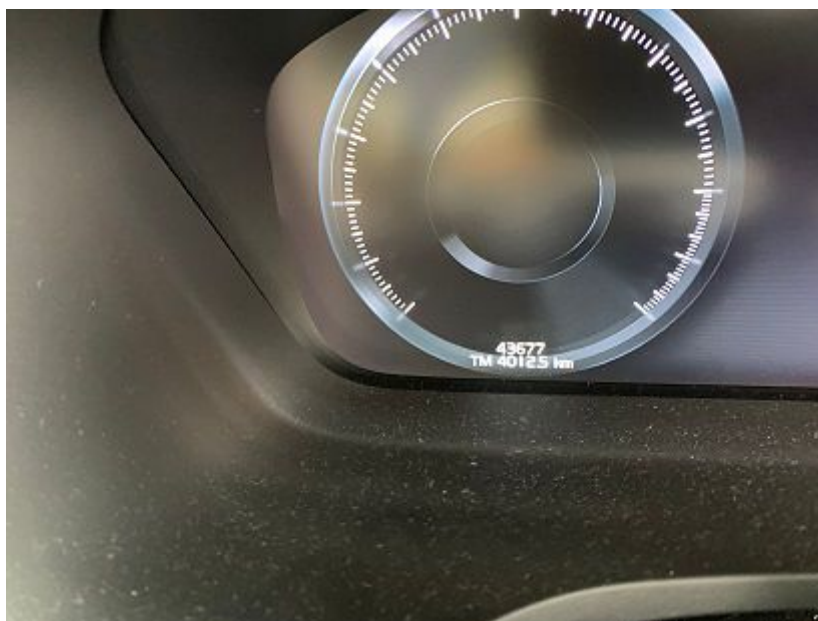
