Brief Details.

On 19/02/2023 at about 0235hrs, I was driving my car bearing registration number SDM7008S along Yishun Ave 8 (from Seletar Dam towards Yishun); there were two passengers on board. While at the junction of Yishun Ave 1, the traffic light was green (in favour for me to proceed straight), a van bearing the registration number GBA3500J which was travelling on the opposite lane had suddenly turned (to its right) to Yishun Ave 1, I was unable to stop in time and the van collided to the front of my car.

I had then stopped my car and checked with the passengers who were both complaining of pain, I had then alighted from my car to check on the damages; my car was badly damaged on the front portion, I was unable to drive the car and I was injured on my back and hip due to the whiplash. The Traffic Police and ambulance arrived subsequently, the passengers and I were conveyed to the hospital. I was given 4 days of medical leave.

I was instructed by the Traffic Police to lodge a report on the traffic accident. I did not exchange particulars and contact numbers with the driver of GBD3500J. My car was installed with dashcam (in-car CCTV) and the memory card was handed over to the Traffic Police officer.
