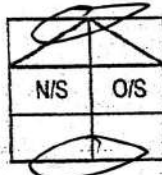

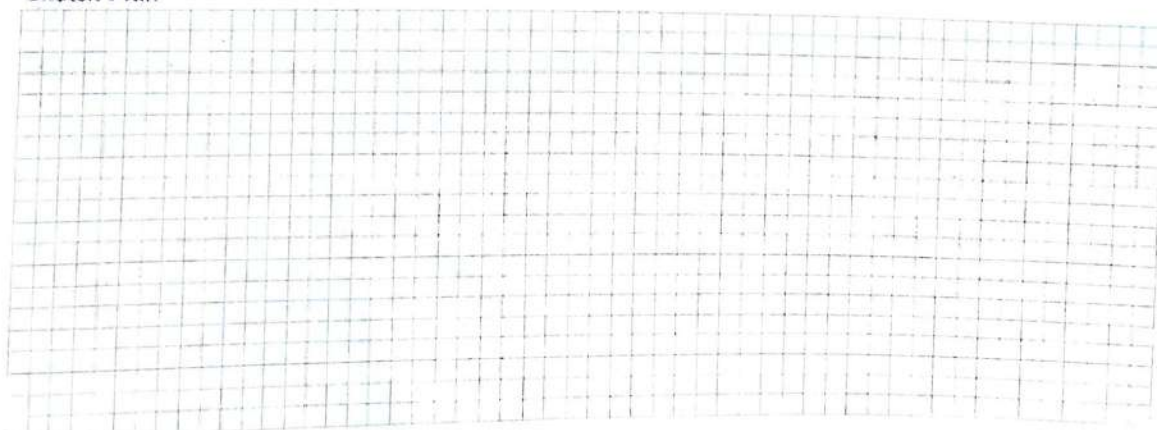

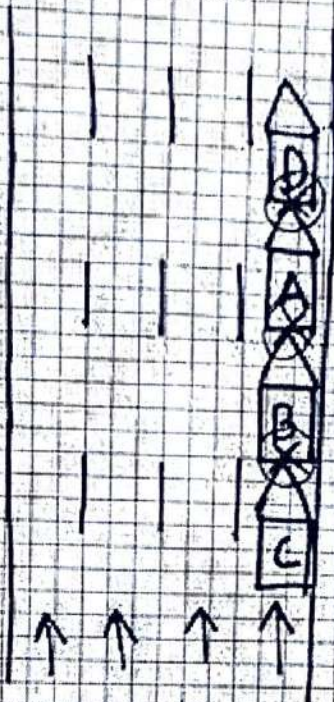
Sketch Plan
