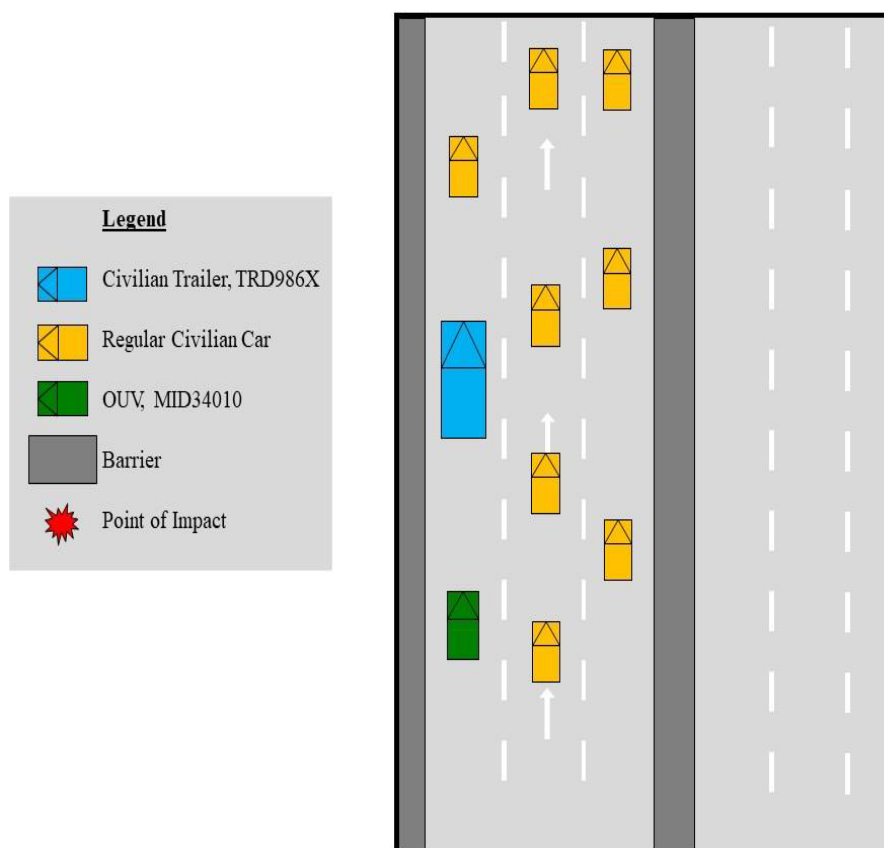


Figure A-1 – Schematic Diagram showing MID34010 travelled along AYE towards Tuas, Corporation Flyover

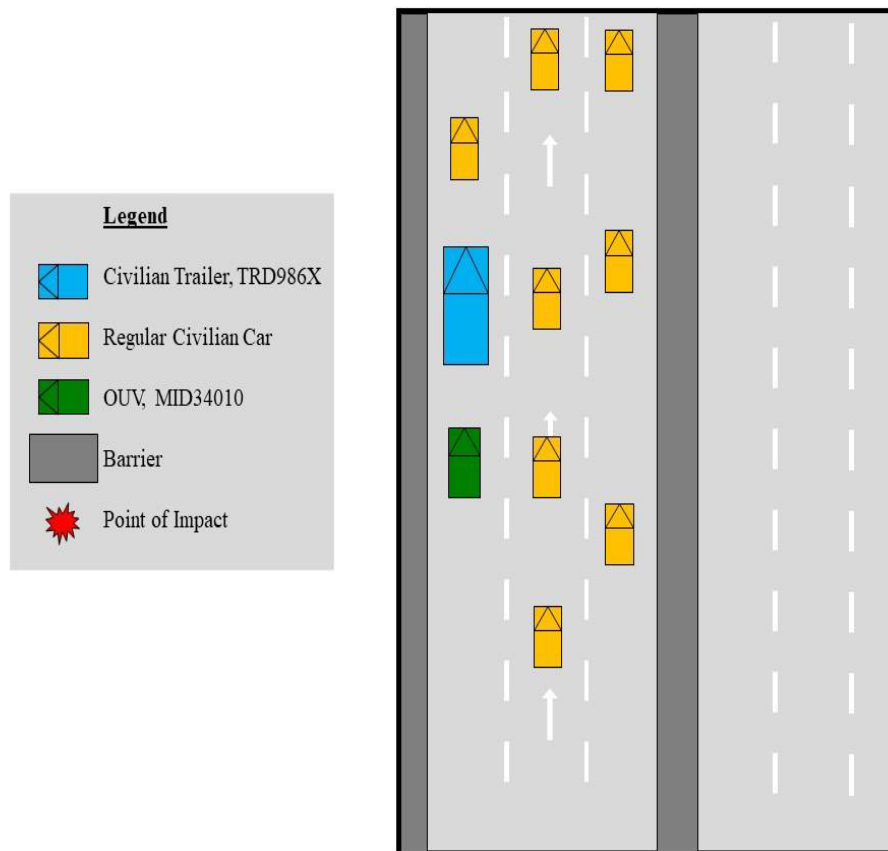


Figure A-2 – Schematic Diagram showing TRD986X coming to a complete stop

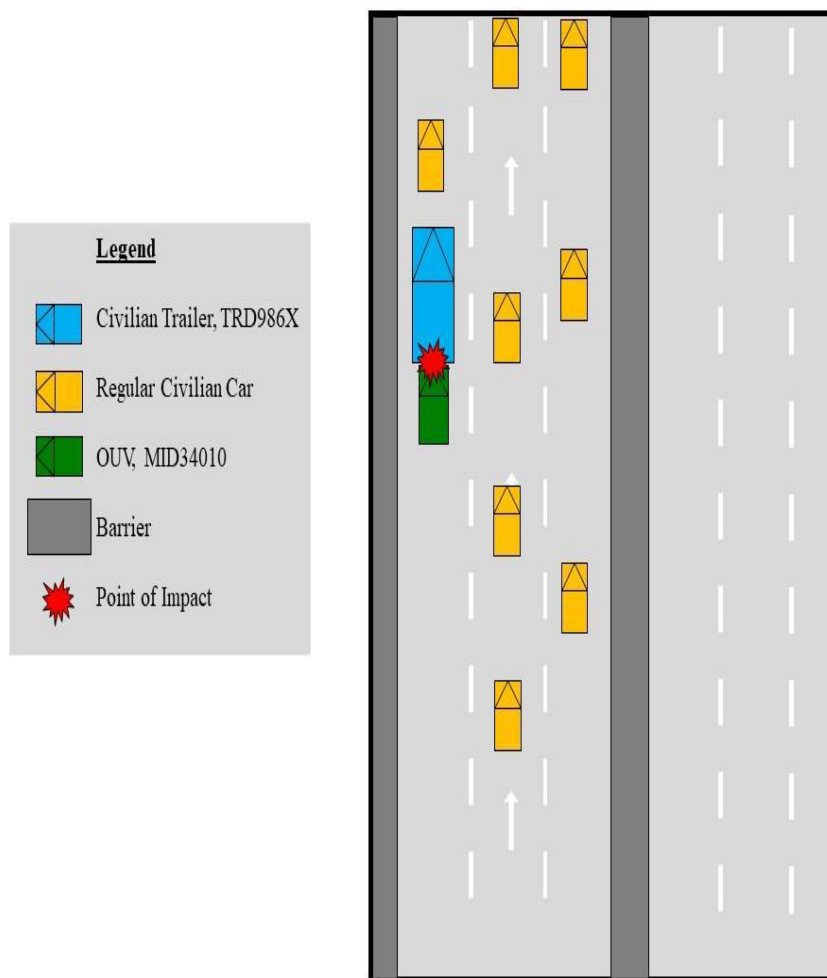


Figure A-3 – Schematic Diagram showing MID34010 failed to brake in time and came into contact with the rear of TRD986X

On 13Feb 2023, at around 0948Hrs, I was driving OUV MID34010 accompanied by front passenger CPL Gerrik. We were doing admin movement from Clementi Camp to Jurong Island. Along the way on AYE towards Tuas near exit 17, there is a trailer in front of my vehicle and I was slowing down and maintaining a safe distance while figuring out if the trailer is slowing down because I could not see if there is any visible brake light. All I could see is the tailboard light. As I was approaching closer to the trailer I realised that the vehicle is slowing down therefore I applied the brake. Despite my best effort I still collided with the trailer because when I am applying the break, the OUV did not came into complete stop in time thus resulting in the collision.
