Brief Details.

I am making this police report now instead of the day of accident, reason being the other involved vehicle (SKR9407B) has decided to make a claim against me. in which during the course of accident, driver of SKR9407B denied my rights for proper procedure of exchanging particulars and taking photos before leaving the accident scene hastily. And this police report is as per insurance claim and requirements.

I was driving along Penang Road and my intention is to go to Plaza Singapura by turning Right at Buyong Road, with proper right turn indicator on, i have signalled my intention and begin to perform a lane change with caution.

My car is already ahead of SKR9407B , my right turn signal is on and i begin my lane change. The position of the the head of my vehicle was already about 3/4 into the lane and the rear of my vehicle was half into the lane. This is when the vehicle behind me (SKR9407B) suddenly accelerated hard, straight into my car and hit my rear left bumper. I stopped immediately after hearing the knock.

When I approached the driver, he waved at my face rudely and said that he is not going to talk and he was going to call the police. I assumed that he is going to call the police next but i was shocked that the next thing i knew he quickly hopped back onto to his car and drove off recklessly. I did not even have the chance to exchange particulars. I also didn't have a chance to take proper accident photos clearly from all angles. In the midst of rushing off recklessly, the driver of SKR9407B almost caused another accident to the Silver Mazda (who horned at him but managed to jam brake and stop in time - see video).

After i checked my video recording I realised that the driver of SKR9407B have a very clear intention of causing an accident deliberately. Throughout the whole entire time, i have turned on my signal light to make known my intention and i was driving very cautiously and slowly while doing the lane change. Firstly, it was very evident in the video recording (10:18:38) that he deliberately accelerated hard directly towards my car, when i am clearly in front of him with more than half of my car body inside his lane. Right after the initial impact, he accelerated again (10:18:43) as if he wanting to inflicted more damage to my car or his car. If only he did not accelerate deliberately, this accident will not happen as there is more than enough space for me to change lane the whole entire time.

The reason why i did not make a report of the accident within 24 hours is because firstly i do

not have any particulars or information about the driver of SKR9407B and secondly the damage to my car was not serious as there are only some minor scratches and all my family members are still safe and sound inside the car. And since the driver of SKR9407B sped off quickly after the accident, I don't see any purpose or need to make a report and i have treated it as a hit and run case with no injury.

Now that the driver is filing a claim against me i would actually think that this could possibly be Insurance Fraud. Firstly he had clear intent of causing an accident when he accelerated hard into me when i have signalled my intention and more than half of my car have already have entered the lane. Secondly he accelerated again after the initial impact as if wanting to "push" my car or cause more damage to either car(s). Thirdly he claimed that he wanted to call the police but quickly went back to his car and sped off suspiciously. And it is very apparent in the video that he is a reckless driver where he did not signal while changing lane and accelerated hard away from the scene almost causing another accident with a silver mazda.
