Brief Details:

On 29/12/2022 at about 2130hrs, I was riding my black in color Yamaha NMAX (FBF2200X) along Ubi Avenue 2 towards Keld Bukit Ave 1 on the second lane. As I approached the junction of Ubi Avenue 2 and Carpenter Avenue of 3021 Ubi Avenue 2, I saw a female student rider inching out before making a U-turn on the opposite side. Despite myself approaching and giving multiple signals such as hi-beam and horn, she continued making the U-turn. I tried to avoid her but was not able to do so on time. As a result, the front portion of my motorcycle collided the rear left portion of her red in color Yamaha YBR125 (FBN7580H). As a result, both myself and the rider fell onto the road.

I suffered pain on both my left shoulder and elbow. I also felt a strain on my left ankle. However, I managed to call for an ambulance which came before Traffic police. I was then conveyed to Tan Tock Seng Hospital where I received treatment and was issued 4 days of MC. I am lodging this report in accordance with IP/CO/WO.
