

On 10/02/2023 at 08:05am along PIE lane 2, road was wet with slight drizzle and traffic was tight but still able to travel ~ 60/70 km/h on the lane 2. Vehicle B in front of me ~~jam~~ jam brake to a complete stop. Upon ~~see~~ ~~seeing~~ ~~upon noticing~~ + Initially slow down with brake. When I noticed ~~the~~ Vehicle B's brake light came out and subsequently hit my brakes hard when I noticed the separation was getting lesser and lesser. 3 seconds before impact, skid marks light came on ~~on~~ at my dashboard but car was not stopping. Vehicle B have minimal damage upon visual inspection.
