

**CONTINUATION OF REPORT**

**Brief Details.**

I am the driver of vehicle with registration no. 'SNB886J'. On 3/2/2023 at about 3:15pm, I was driving along Victoria Street, however I made a wrong left turn and decided to drive into Cheng Yan Place to get back to my journey. I then made a stop at the stopping line at Cheng Yan Place. At this juncture, my vehicle was at the left lane of Cheng Yan Place. There was another vehicle, Blue in colour, who was blocking my view from my right. I then inched out from the stopping line to get a better view. I then saw a single deck bus approaching from a distance; hence I decided to wait and give way to the bus. As I was waiting for the bus to clear, suddenly I felt my car vibrate and felt an impact on my vehicle. I then realised that my vehicle was hit by the bus.

Subsequently, I drove into Victoria Street and stopped my vehicle behind the said bus. I then alighted from my vehicle and approached the bus driver. I then told him that he had hit my vehicle, and he mentioned that he did not feel any impact. Hence, I suggested to him to make a check. He then alighted from the bus and made a check on my vehicle. The said bus driver then went back to the bus and asked the passengers in his bus to alight. He came back to where I was standing, and I asked him how to settle the accident. He then mentioned that he is unable to settle the matter privately as he has to inform his company about the accident. I then asked for his particulars and contact number, and subsequently he provided with the information willingly after he consulted with his company. After which, we parted ways, and I made my way to the Police station to lodge a Police report.
