

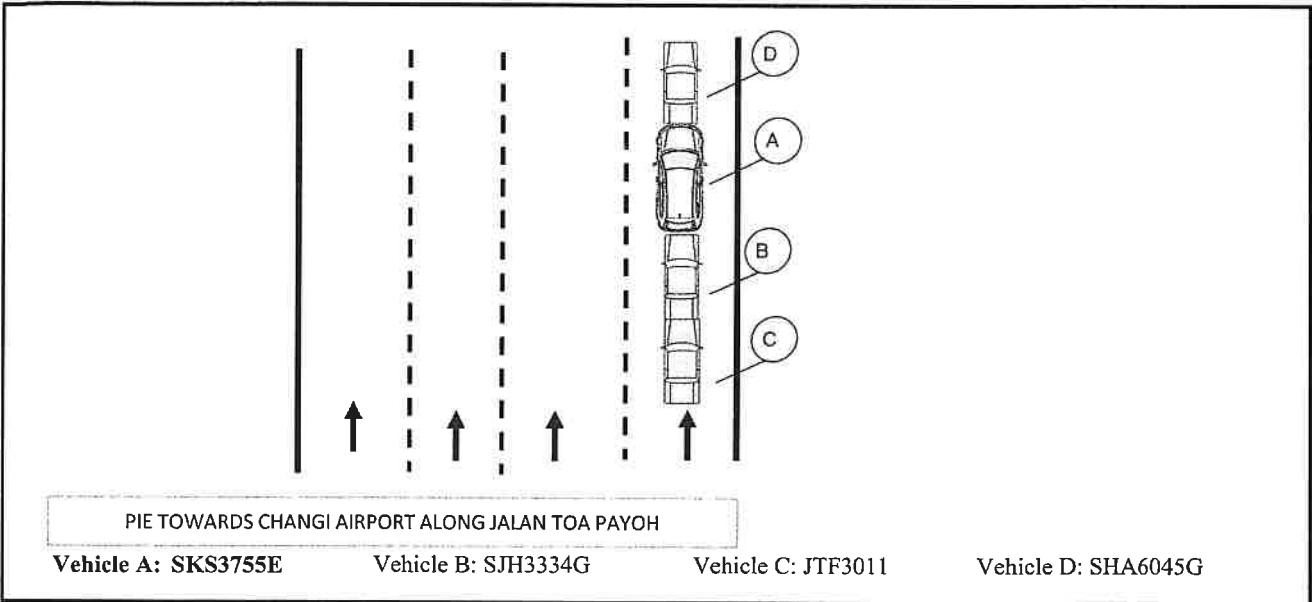

SKETCH PLAN



CONTINUATION OF REPORT

Brief Details.

On 30/08/2019 at about 7.55am to 8am, I was driving my vehicle(SKS3755E, Red Honda) along PIE towards Changi Airport along Jalan Toa Payoh at the first lane where the taxi(SHA6045G, Blue Hyundai) infront had slowed down and come to a stop. I had then slow down and come to a stop as well. However, out of a sudden, one vehicle(SJH3334G, Blue Toyota) had came from the back and banged against my vehicle. The collision had caused my vehicle to move forward and bang against the taxi infront as well.

After the accident, I had alighted my vehicle and spotted that there was another Malaysia vehicle(JTF3011, White Toyota) which was involved in the accident as well. The Malaysia vehicle had banged against the back of the vehicle SJH3334G. After the accident, I had exchange particular with the driver of the taxi and the driver of SJH3334G as I thought that my vehicle accident was involved with the two of them only. After which, we left as there was a heavy jam and it was drizzling. The damage on my vehicle is front and rear bumper dented and scratches. The rear right sensor had dropped off as well. The vehicle rear bumper right side had also misaligned.
