Brief Details.

On 04/03/2023 at about 2115hrs, I was driving my vehicle along Jurong Town Hall Road facing West coast road. When I was turning right to AYE Towards Tuas, my vehicle (V1:YP1168M) was at the outer lane when turning when another vehicle (V2: SMY9680S) at the inner lane hit onto the right side of my Lorry while turning resulting in V2 having a small dent at the front left side of the vehicle.
