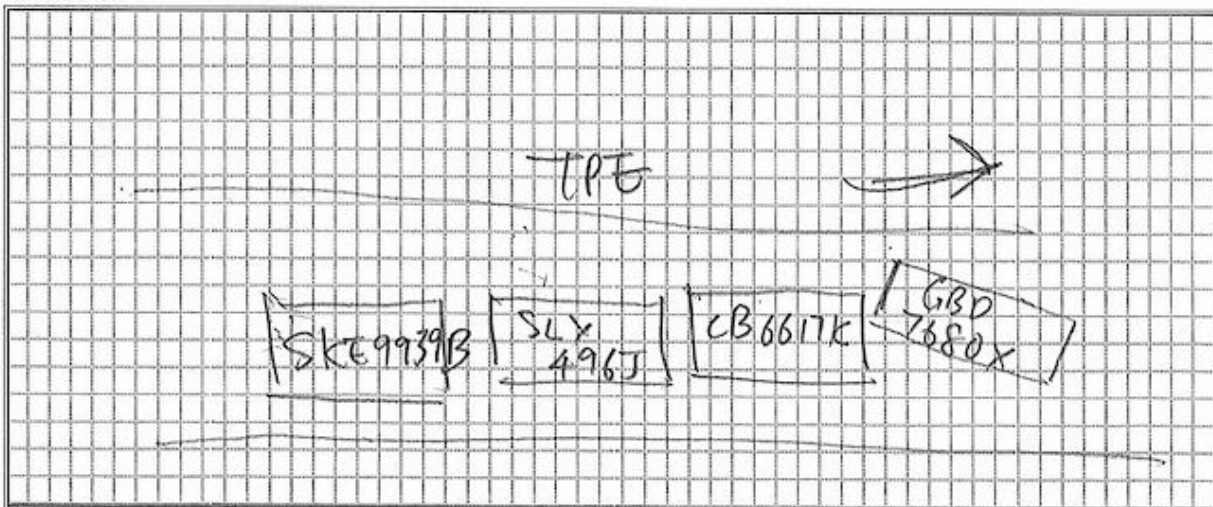

Describe Circumstance of the Accident

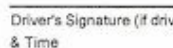
Lorry GBD7680X tries to cut into the lane in front of
