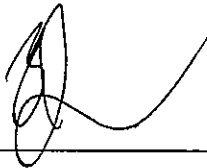

Brief Details.

On 19/11/22 at about 0750hrs I was riding my motorcycle (JSB5737) along Ang Mo Kio Street 61, proceeding straight. It was raining and the road was wet. A vehicle (SMN5007X) suddenly turned out from the carpark of Blk 620-632 Ang Mo Kio and collided onto the front of my motorcycle. Due to the collision, I fell back off my motorcycle. The driver of the vehicle came down to check on me.

A passerby who claimed to be a paramedic told me to stay lie down and wait for paramedics. Shortly after ambulance came and I was conveyed to Khoo Teck Puat hospital for medical treatment. I was conscious all the time.

I was discharged on 20/11/22. I was given 5 days of medical leave and 7 days of light duty. I sustained fracture at left shoulder, abrasions on left side of face and 3 stitches on my right hand, near to thumb area.

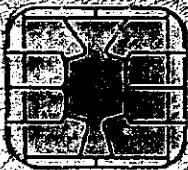
