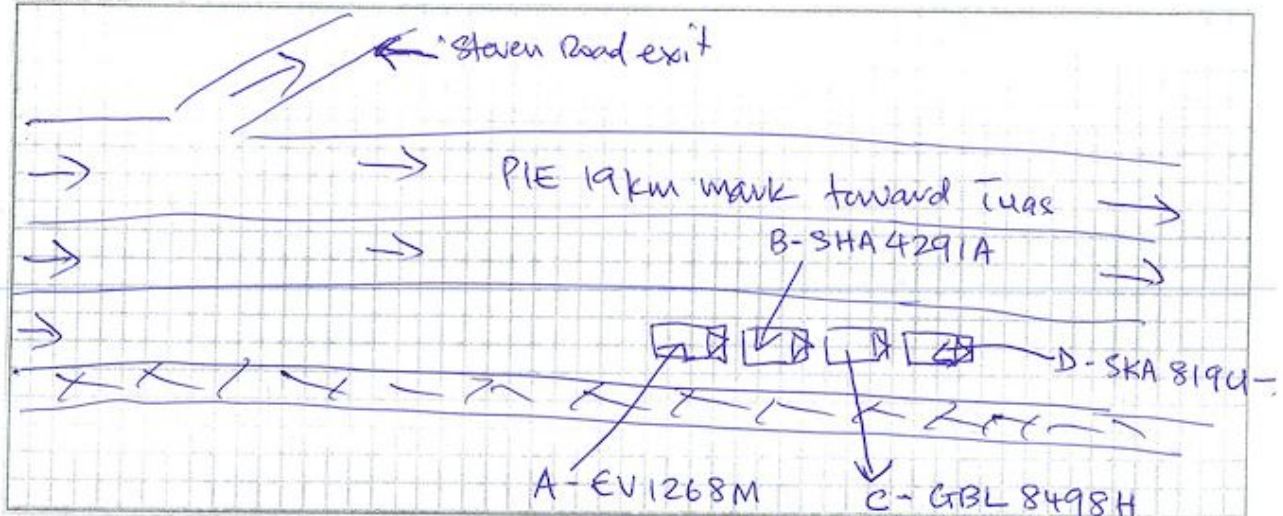


Sketch Plan

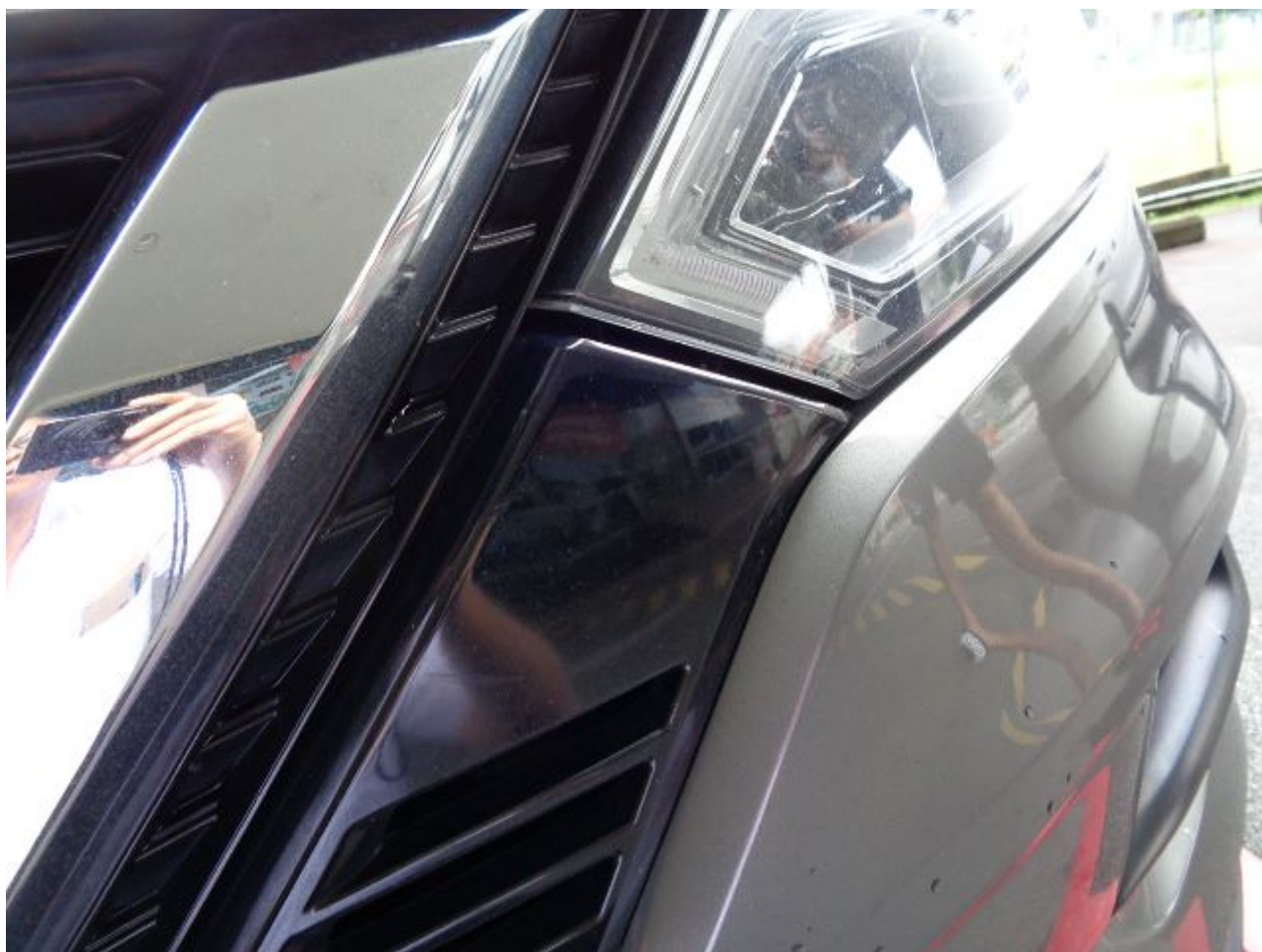


















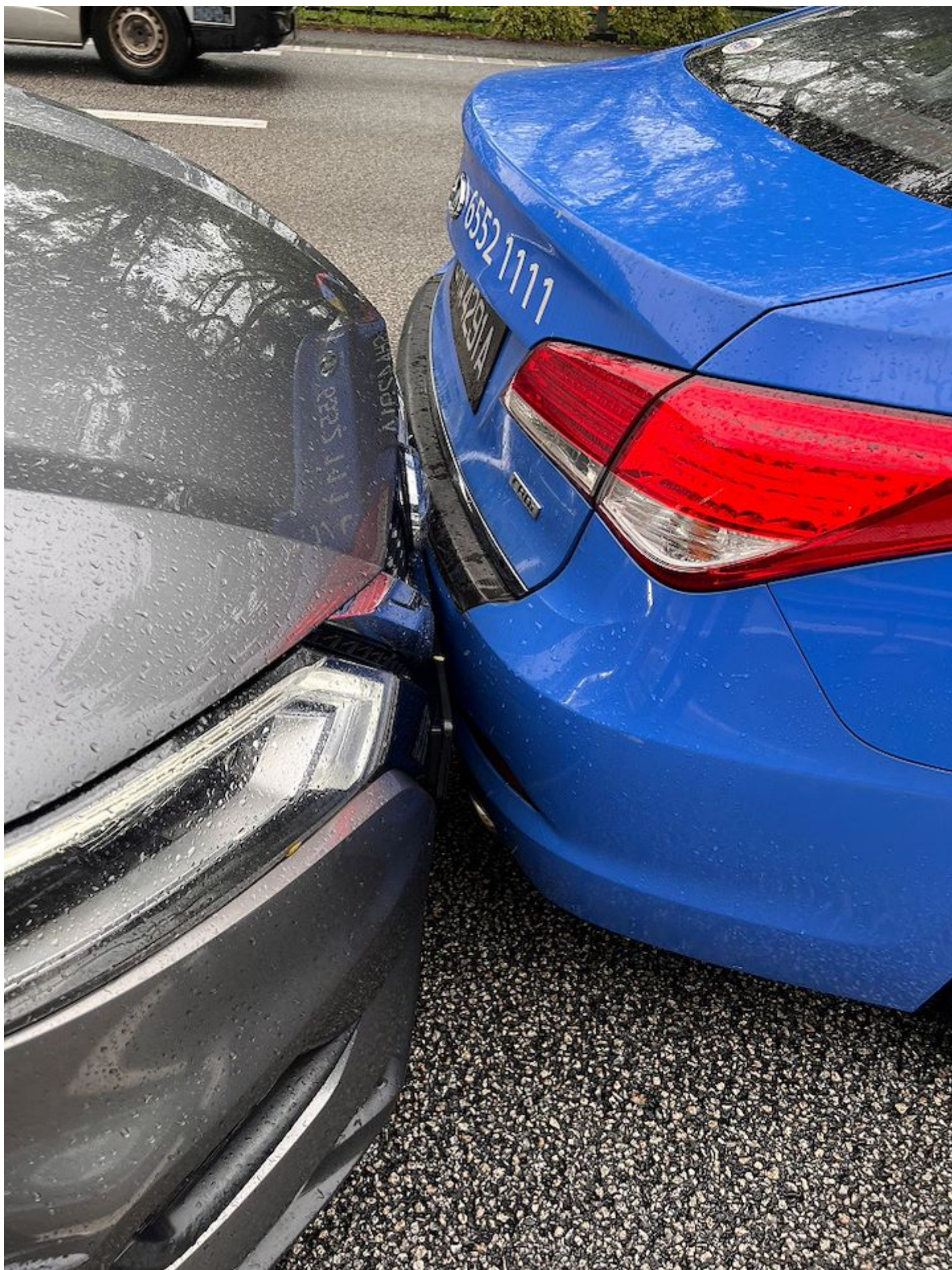
