Sketch Plan

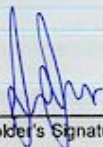

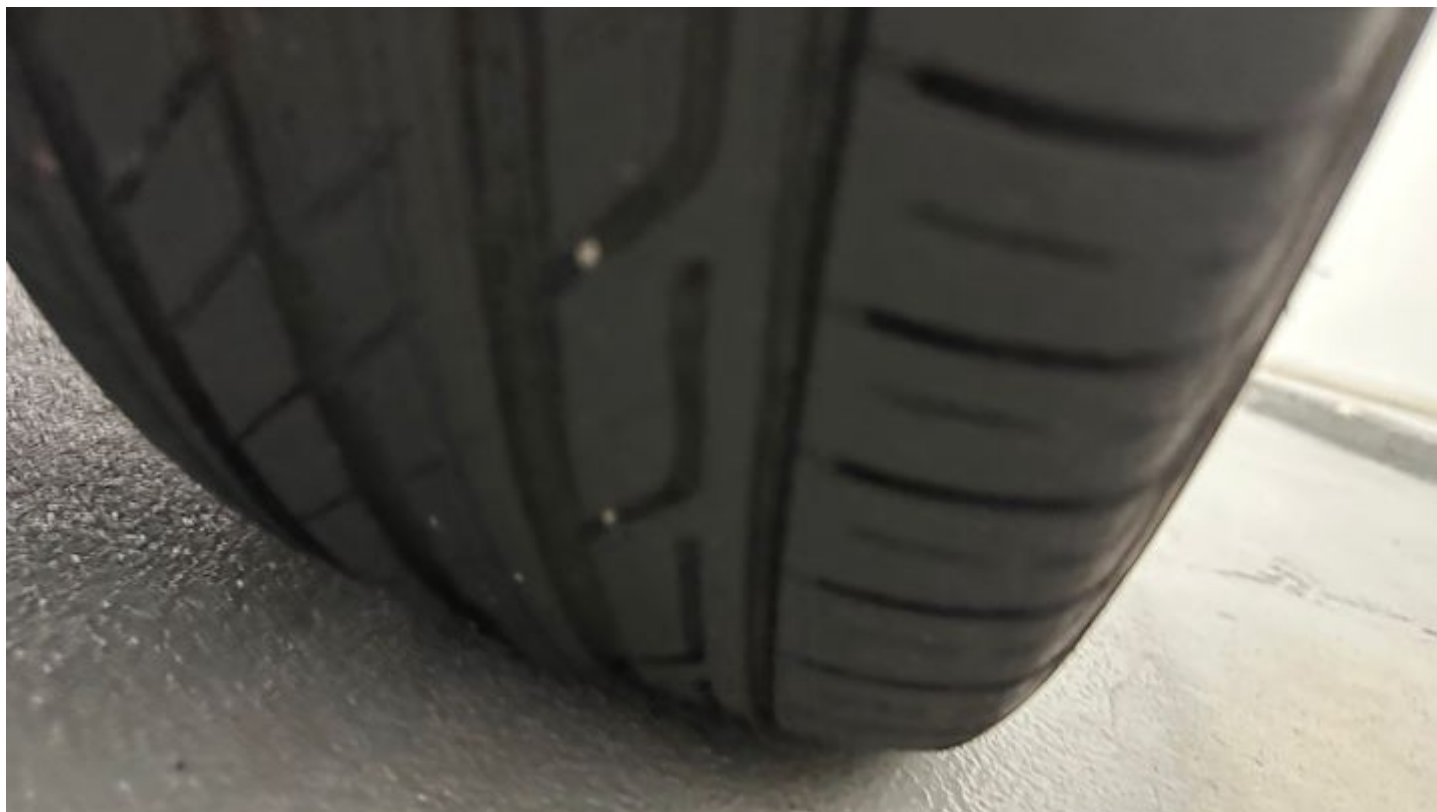






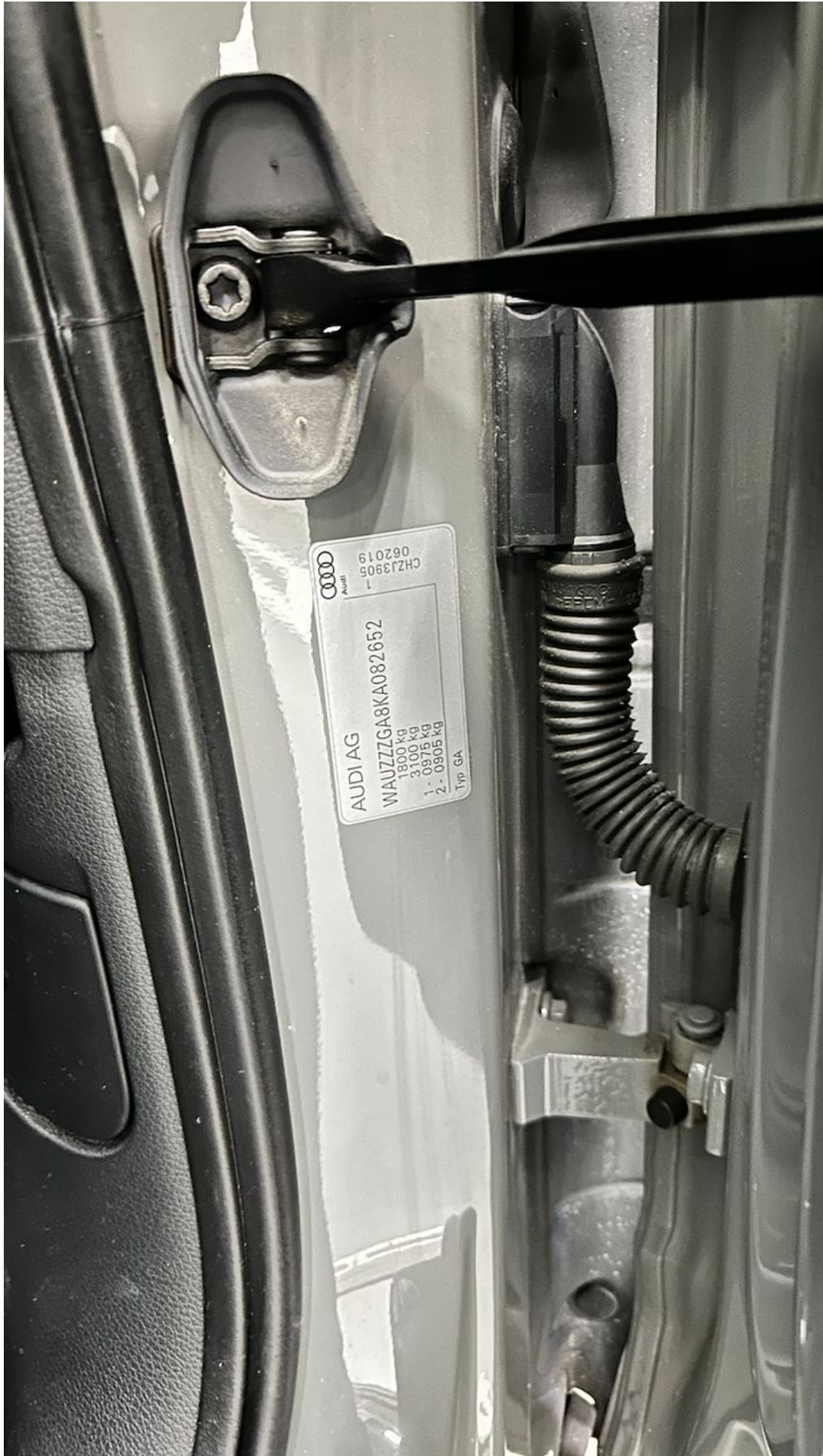
