On the evening of 9th march 2023, I was driving (license plate SMT3228G, black Porsche Cayman) on the furthest right lane on the way back home from work on the ECP at around 5.20-5.25pm when the car in front of me began to slow down before fully stopping. I managed to slow down to stop my car from hitting the front car in time. However, I heard a loud sound from the back after which I felt the car behind mine bang into my car rear which caused me to hit the car in front of me.

I turned off my engine and came out to assess the damage and /or any injury to myself and the fellow drivers. The front driver (license plate SLX6114Y), Rohaizad Bin Mohammed Ismail, \$1792891J, said that the car infront of him at suddenly stopped so he had to suddenly hard brake. He acknowledged to

me that I had stopped in time and didn't initially bang his car but later heard a delayed banging sound which led to my car banging into his car rear. He told me he was fine and assumed everyone was ok so he left but gave his details for insurance claim purposes.

I spoke to the car driver behind me , Muhammad Siraaj Bin Mohamed Anwar, S8532751H , license plate SLU6457Z , and he said he managed to stop in time as well but heard a loud bang behind his car before feeling his car get hit which caused his car to bang into my mine. He mentioned that his family who were in the car and he were all fine albeit in shock because it was their first road accident on the express way. After observing the accident as a whole , I realised that my car was the second car in a 7 car pile up accident on the ECP towards Changi Airport (10km from Changi Airport) . I waited for the police officer on the scene to take all of our particulars and statements for his report (E/20230309/0110) before allowing us to leave then I drove off home.
