#### CIRCUMSTANCES OF ACCIDENT

I WAS PARKED AT THE PARKING SPOT FROM 09:53 AM ON 13 MARCH 2023 AND DISCOVERED THE DAMAGE ON THE CAR WHEN I WAS ABOUT TO LEAVE AT 2:45 PM (13 MARCH 2023). THERE HAD BEEN DAMAGE ON THE FRONT RIGHT SIDE OF THE CAR AND THE FRONT BUMPER FELL OFF, WITH CRACKS ON THE GLASS (FRONT LIGHT) AND OTHER CRACKS ON THE SAME SIDE. THE DRIVER THAT HIT MY CAR LEFT A NOTE AND CONTACT AND INFORMED ME THAT THE CAR WAS NOTED TO LEAK FLUID AT THE TIME OF COLLISION AND SUGGESTED FOR THE VEHICLE BE TOWED AWAY FOR SAFETY CONSIDERATIONS. THERE HAD BEEN A WITNESS, STEVEN TAN, WHO ALOS INFORMED ME THAT HE WITNESSED A MERCEDES HITTING MY VEHICLE WHEN THE OTHER DRIVER WAS TRYING TO REVERSE OUT OF ST JOSEPH INSTITUTION'S (SJI) COMPOUND.

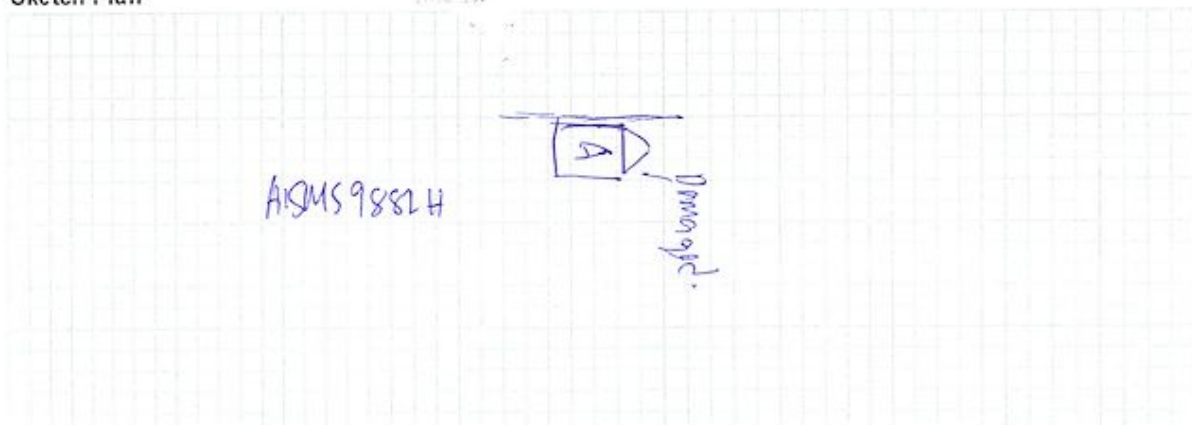

## Describe Circumstances of the Accident

I was parked at the parking spot from 0953am on 13 March 2023 and discovered the damage on the car when I was about to leave at 245pm (13 March 2023). There had been damage on the front right side of the car and the front bumper fell off, with cracks on the glass (front right) and other cracks on the same side.

The driver that hit my car left a note & contact and informed me that the car was noted to leak fluid at the time of collision and suggested for the vehicle to be towed away for safety considerations.

There had been a witness, Steven Tan, who also informed me that he witnessed a Mercedes hitting my vehicle when the other driver was trying to reverse off out of St Joseph Institution (SSI) compound.
