Sketch Plan

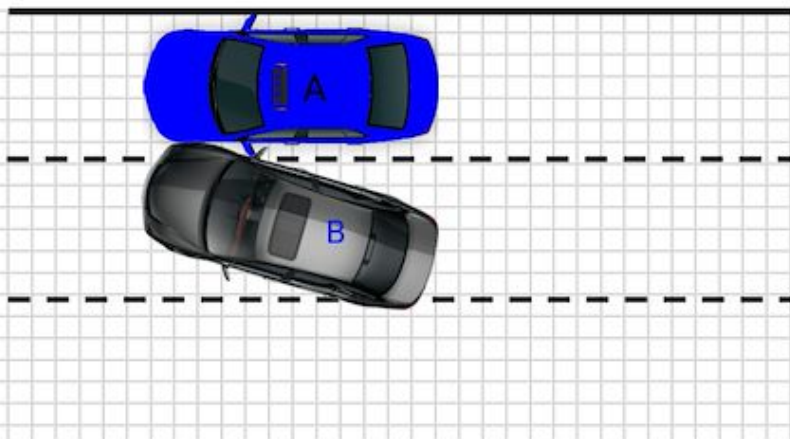
