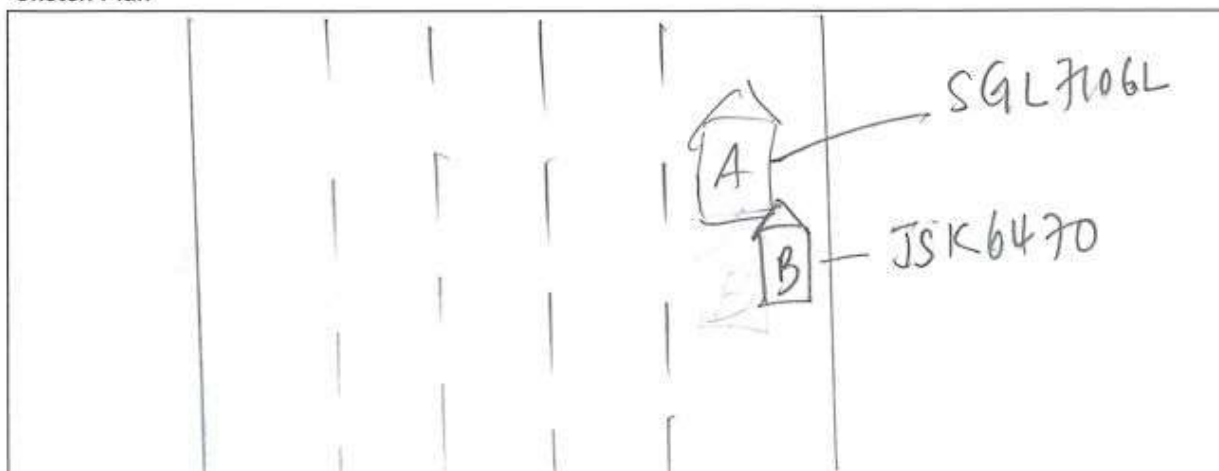

CONTINUATION OF REPORTBrief Details.

1. The time was around 9:20am earlier this morning Fri 17 Mar 2023.
2. I was driving my car on AYE in the direction of Tuas before exit 9.
3. Due to a road accident being indicated on the signboard, the traffic was very slow or on even stationary at times.
4. I was on the second lane, from the right, of AYE.
5. While my car was creeping forward on the second lane, a motorcycle JSK6470 hit my car from behind onto the right rear-light and also the right side of my car.
6. The motorcyclist admitted that it was his fault, he was lane cutting and he didn't see my car.
7. A police officer was present. His name is Cavin. I told him what happened.
8. The police officer was present when the Malaysian biker admitted that it was his fault because he was lane cutting without properly checking.
9. As mentioned, the traffic was slow, the speed of my car was slow, because of the traffic-accident indicated on the road sign. The Malaysian biker basically did not check properly, and knocked onto my car.
10. My car, the right hand side, and rear right hand side; all damaged.
11. Many cars were on the road and traffic was heavy. So the biker was lane changing without checking properly.
12. Because the traffic was slow, yet the biker knocked onto my car, and there were many cars on the road, all slow. This was somewhat outrageous that the motorcycle knocked onto my car given the slow traffic conditions. The reason is straight forward: he did not check properly and he admitted this when police officer Cavin was present.
