Dear Sirs,

We have submitted our recovery claim against ERGO Insurance Pte. Ltd. They have replied that they are unable to settle our repair cost based on TCA clause 3(a). - "If the amount of the damage to neither the Government Vehicle nor the Insured Vehicle exceeds \$500 each party shall bear its own loss, if any, in respect of such damage".

3. In the event of a collision occurring between a Government Vehicle and an Insured Vehicle under a Comprehensive Policy –

- (a) If the amount of the damage to neither the Government Vehicle nor the Insured Vehicle exceeds \$500/- each party shall bear its own loss, if any, in respect of such damage.
- (b) If the amount of the damage to either the Government Vehicle or the Insured Vehicle exceeds \$500/- but the amount of the damage to neither vehicle exceeds \$10,000/- each party shall bear one-half of the damage to the vehicles.

We attached here with a copy of email correspondence with Ergo for your reference.

Please advise if SAF would like to pursue the claim against civilian or proceed to close case as the claim amount is \$132.84.
