#### Brief Details.

I was driving my car (SML5277T) along PIE towards Tuas, in between Stevens Rd and Adam Rd, on 12/03/2023 at about 2pm when the car in front of me suddenly jammed break. I managed to jam break to avoid a collision with the front car, however, the nature of the incident resulted in the car (SJH5445G) behind to crash headfirst onto me. The front of my car was slightly dented with my rear being even more dented. There were about 10 - 11 vehicles in this chain collision accident. Several parties were conveyed to the hospital. I was not physically injured but I went to the Mount Alvernia Hospital for a CT scan, no injuries so far. Traffic Police Sgt (3) T09915 Md Ridwan attended to me on the scene. I have in car camera footage of the accident and my SD card has been seized by the traffic police officer.
