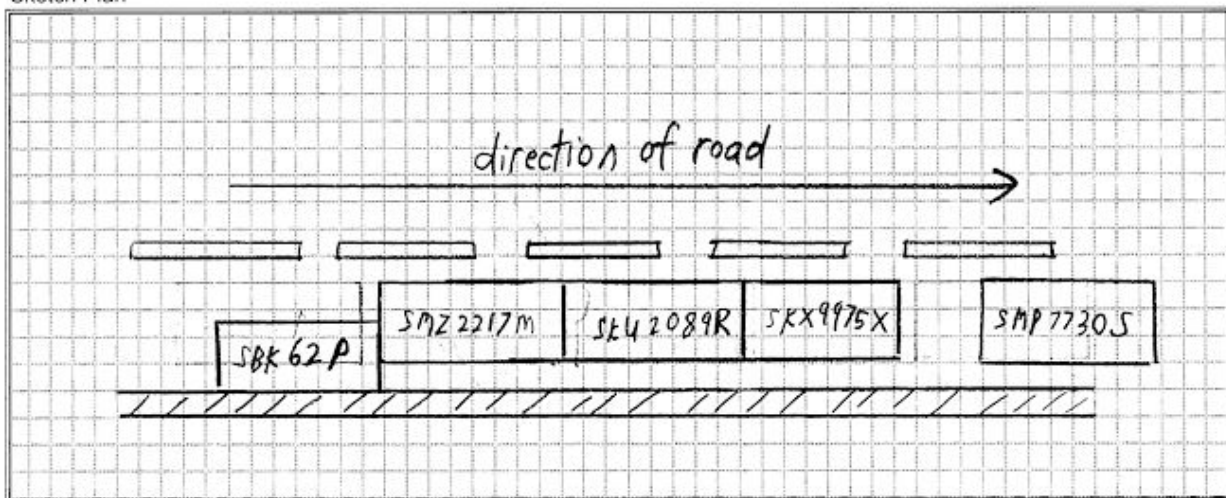

Describe Circumstance of the Accident




I was driving along the PIE in lane 1 and it was raining. I was mindful to leave a safe distance from the car in front due to the weather creating lower visibility and to give myself enough reaction time in an event of emergency. I also noticed that the car behind me (SBK 62P) was not keeping a good distance from me.

Along the way, I noticed that about 3 or 4 cars in front were starting to brake and so I started to brake as well to anticipate these cars coming to a complete halt. True enough, the car in front of me (SKU 2089 R) came to a complete stop. I applied the brake further and have slowed down enough to stop and avoid hitting SKU 2089 R vehicle. However, my car was jerked forward from the impact of hit from my back, causing the car to move forward forcefully and impacting the car in front of me.

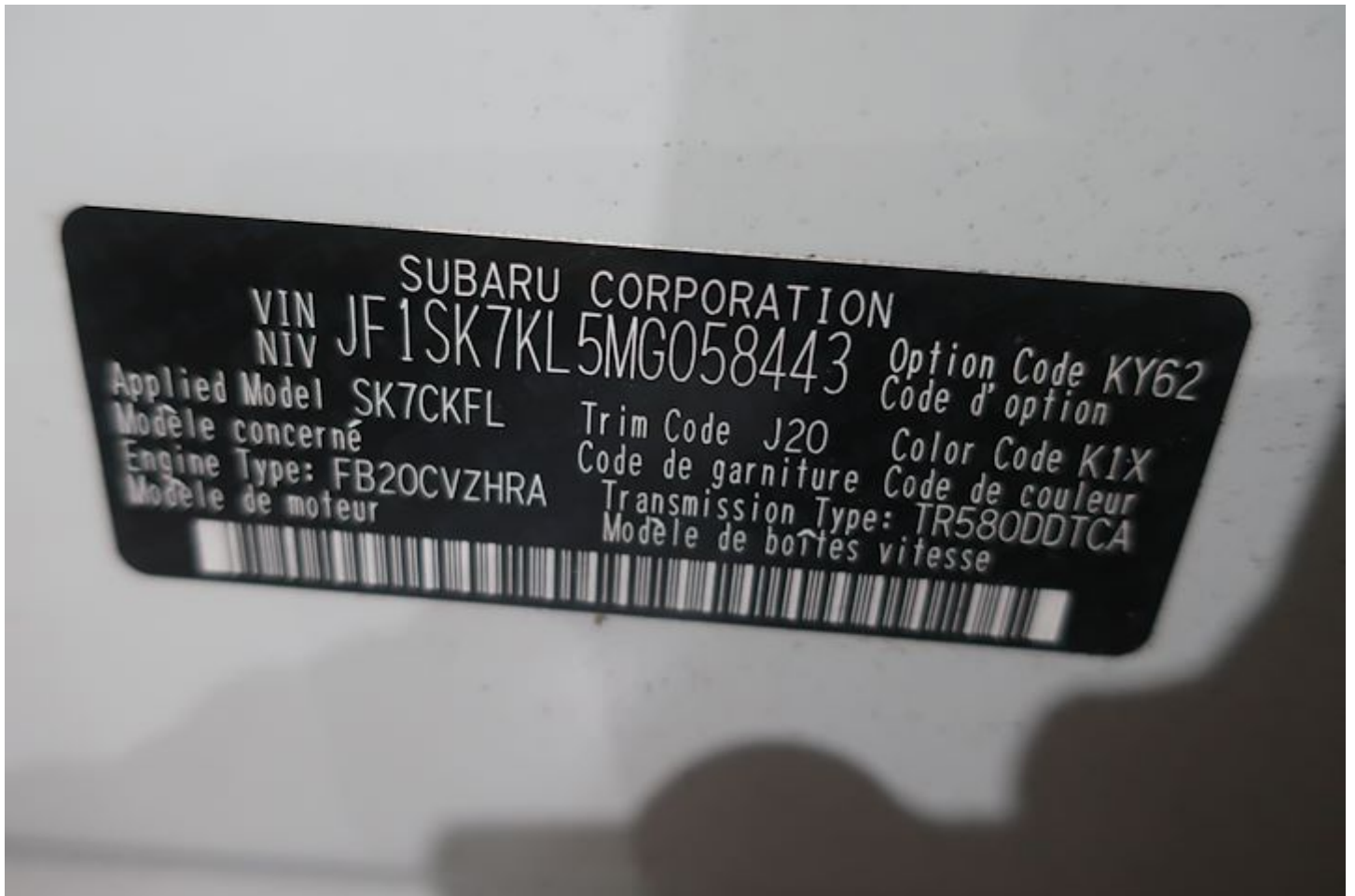

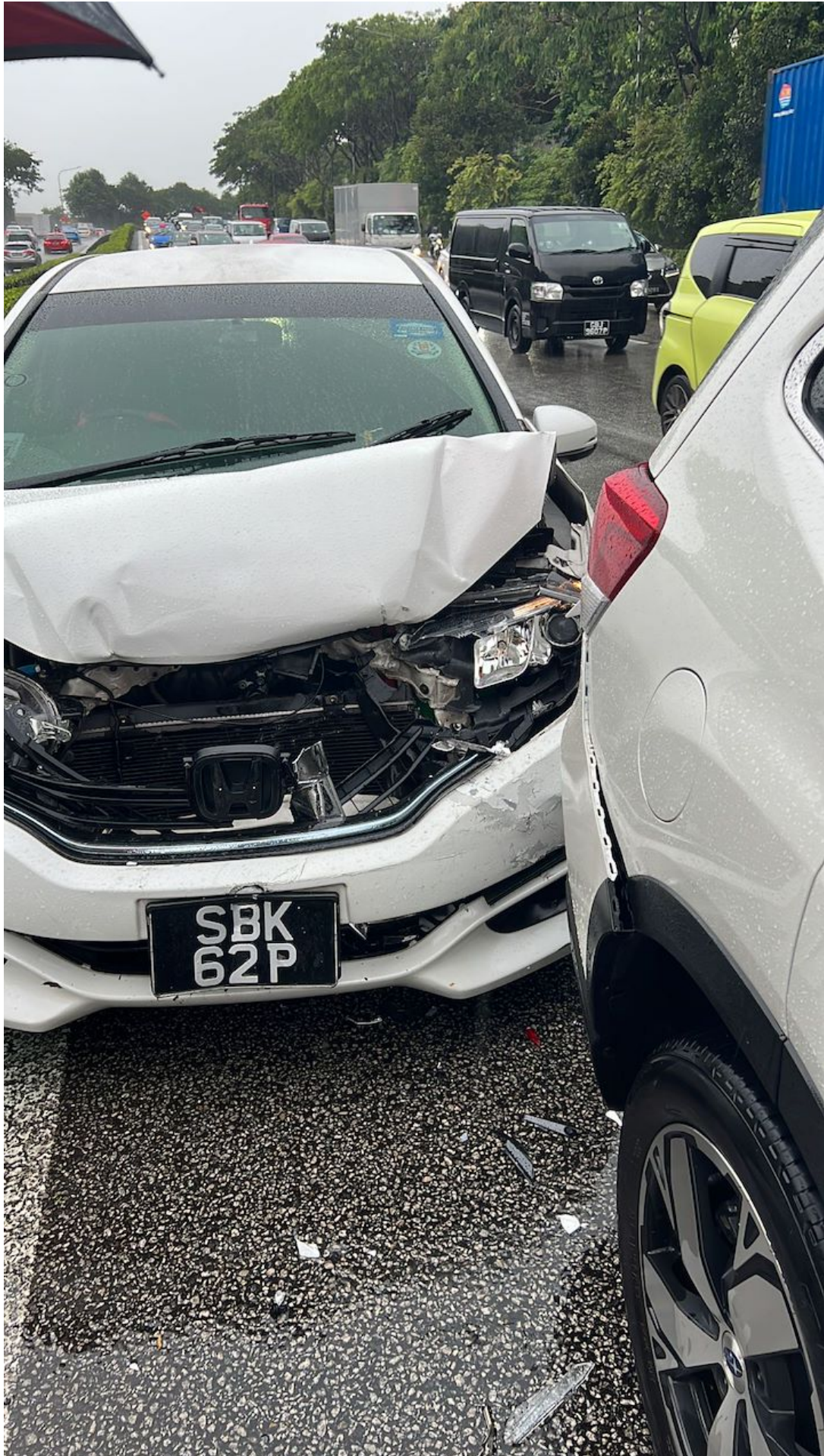
