ALLEGED HIT-AND-RUN ACCIDENT INVOLVING PC927X & YL9446D ALONG AYER RAJAH EXPRESSWAY ON 08 MARCH 2023 AT 1200 HRS

Our investigations showed that you are the registered owner / driver of motorcar, PC927X, allegedly involved in the said accident.

- You are required to provide the particulars of the driver on the above date and time <u>within 14 days</u> of receipt of this letter. Under the provisions of the Road Traffic Act, it is an offence not to provide the driver's particulars, and the owner can be liable to a fine of up to \$1,000/- or 6 months' imprisonment.
- In addition, please inform the driver to lodge an online **Traffic Accident Report** using Singpass via http://www.eservices.police.gov.sg. Alternatively, the report may be lodged at any Police Post or Neighbourhood Police Centre. Do note that failure to lodge a report may have an adverse effect against the involved party.
- The information given by the driver in the report will be carefully considered. The driver may not be called upon an interview if the information provided is sufficient for our investigation. If you have video evidence, you can send it to the Investigation Officer (IO) via email Sufiyan_Khairi@spf.gov.sg. Brief Details.
