Brief details.

At 1422, around Eunos link near Comfortdelgo Driving Centre, military vehicle MID 41629 was turning into the filter lane. As the military vehicle was turning, the civilian company vehicle in front, GBK1205M, stopped immediately. Serviceman was not able to brake in time, causing the military vehicle to bump slightly into the front vehicle, causing minor scratches on the vehicle's front carplate and the back of the civilian vehicle. Both drivers exchanged particulars. Neither party sustained any injuries
