Brief details.

At 1422, around Eunus link near Comfortdelgo Driving Centre, military vehicle MID 41629 was turning into the filter lane. As the military vehicle was turning, the civilian company vehicle in front, GBK1205M, stopped immediately. Serviceman was not able to brake in time, causing the military vehicle to bump slightly into the front vehicle, causing minor scratches on the vehicle's front carplate and the back of the civilian vehicle. Both drivers exchanged particulars. Neither party sustained any injuries

Travelling along Airport Road exiting Eunos Link from a filter lane when the Civilian vehicle was moving slowly and braked abruptly.									
As I noticed that the car had Stopped, I alerted SSG Elister immediately. However, as it was a sudden alert,									
SSG Elister could not react in time and rear-ended the civilian vehicle. Both parties drove To the side of the road to exchange each other's particulars before leaving the scene.									
The traffic police and SCDF ambulance were not activated at the scene and There were no injuries reported. No medical attention									
Had to be seek as well. Minor damages such as an indent in the license plate were observed on the front of The GP car and a									
slight Scratch at the rear of the Civilian vehicle.
