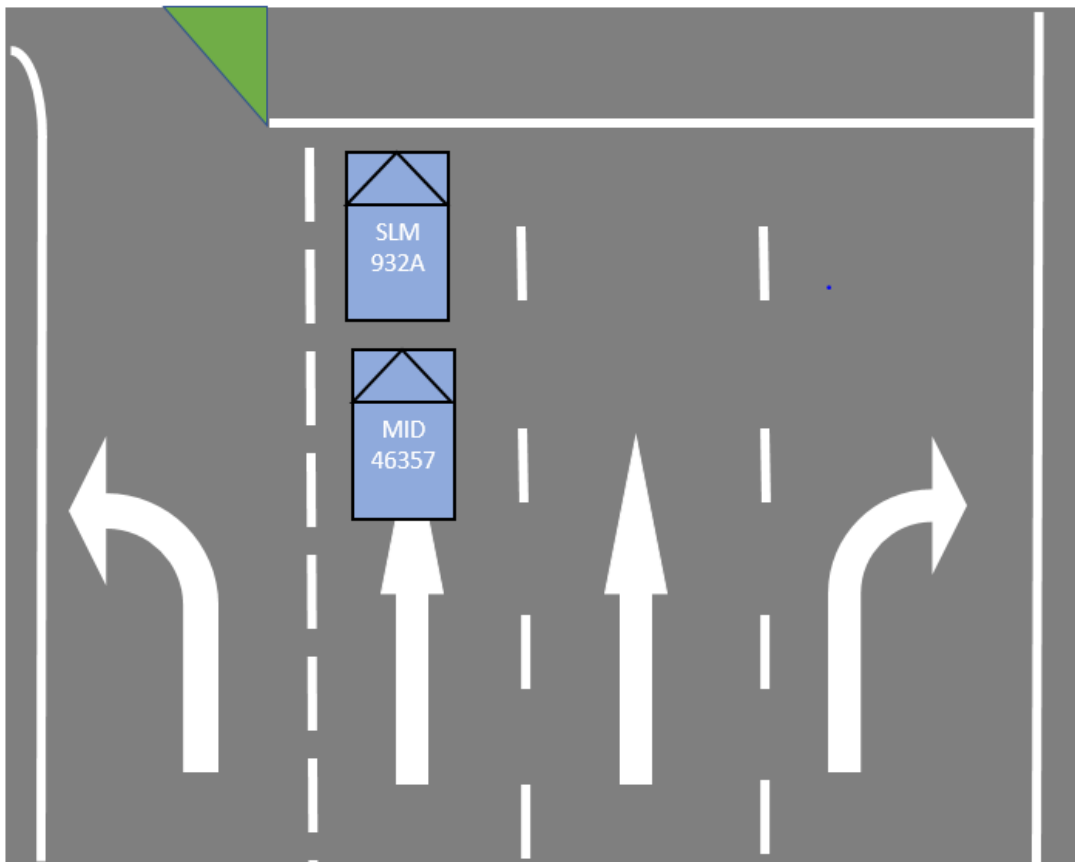
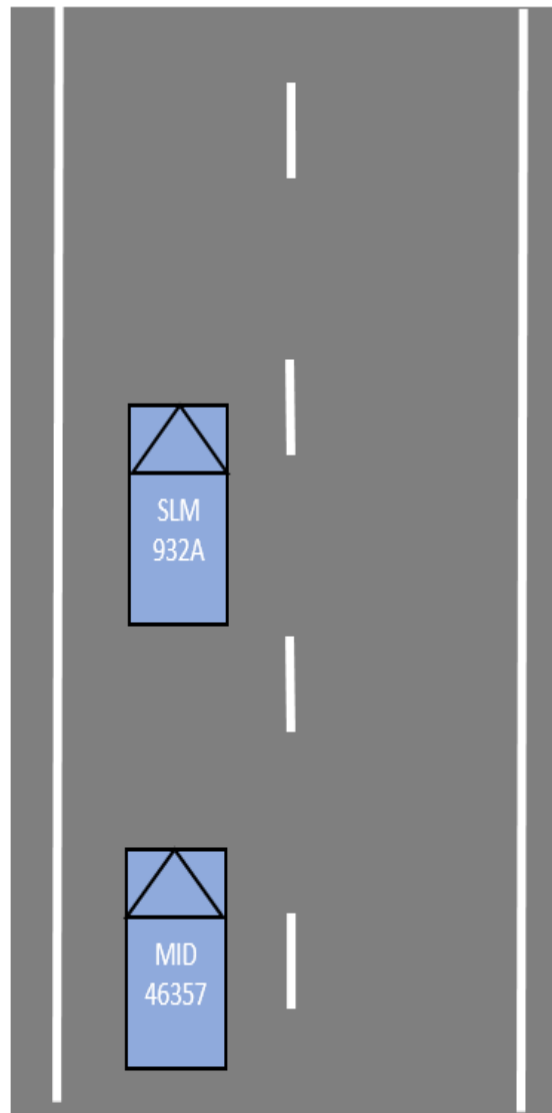

ON 21 MAR 2023**



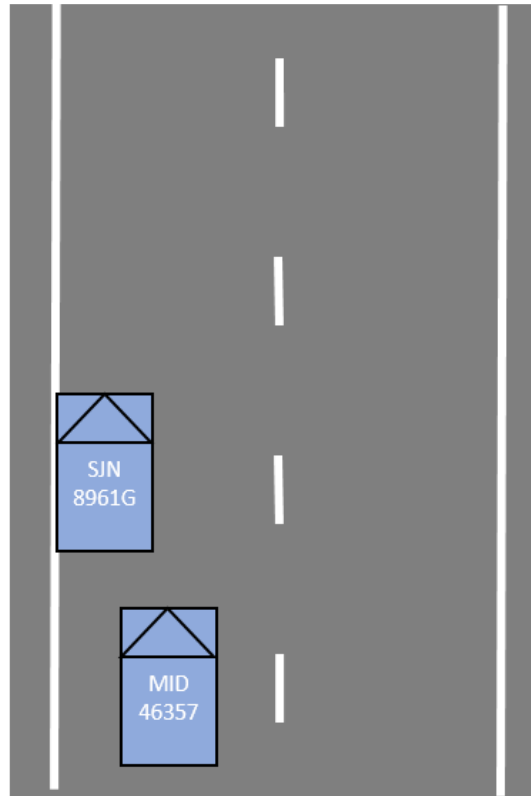
MID46357 was moving along Teck Whye Avenue straight onto Choa Chu Kang Drive

Figure 1A: Schematic Diagram



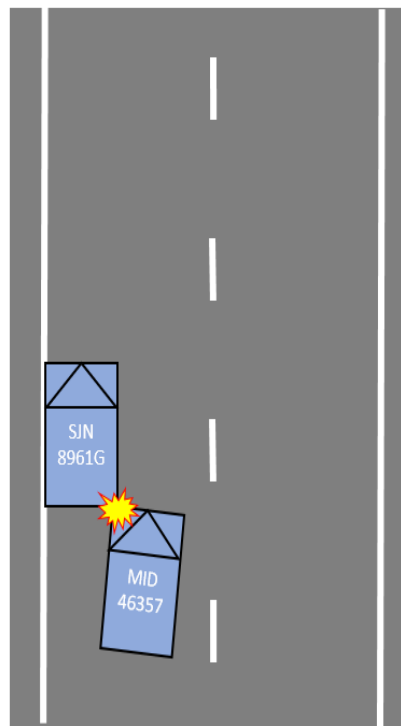
MID46357 was moving behind SLM932A at a safe distance along Choa Chu Kang Drive

<p>I, LCP LEONG EE HAN DANIEL, was driving with my vehicle commander 2SG KOH YIK HENG RYAN, at 1330hrs to arrive at SUNGEI GEDONG CAMP from STAGMONT CAMP on vehicle MID46357 (GBF 8459C). I was driving to familiarise myself with the routes and gain confidence in driving to potential operation sites.</p> <p>I was driving from STAGMONT CAMP to SUNGEI GEDONG CAMP and was on Choa Chu Kang Drive travelling to SUNGEI GEDONG CAMP at 1330hrs. The other vehicle involved in the incident started to slow down and stop 4 metres in front of me. My reaction was then to slow down immediately. However, I was determined that the braking while continuing straight forward would result in a frontal collision, so I made the decision to change lane to the right after realising it.</p> <p>Unfortunately, I did not manage to change over in time, resulting in our cars coming into contact.</p>

<p>I, 2SG KOH YIK HENG, RYAN, was the vehicle commander for MID46357 (GBF8459C). We were turning into Teck Whye Avenue on the way to Sungei Gedong Camp at 1321hrs.</p> <p>As we were turning into Tech Whye Avenue, a civilian vehicle turned on his hazard lights and started to slow down to pick up a passenger about 4 metres ahead of us. Upon seeing the hazard lights on the civilian vehicle, I informed my DV to slow down and be prepared to make a right turn onto the right lane to avoid the stopping vehicle. However, my DV did not make a big enough turn and collided into the right rear end of the civilian vehicle.</p> <p>After which, I informed my DV to continue driving up to the front of the civilian vehicle to avoid blocking off the other lane. I reported the incident to the conducting body, who then assisted me and my DV in taking down the civilian particulars and handling the situation. We contacted the VRS shortly after and was brought back to Stagmont Camp after the report was made.</p>

On 210323, at 1330H, I was driving my vehicle GBF8459C (MID46357) accompanied by my vehicle commander Koh Yik Heng, Ryan, along (Chua Chua Kang Avenue 1) towards Sungei Gedong Camp. I had just crossed the traffic light with another car ahead of us with a double decker bus in front of it. The car ahead of us started to brake and stopped before a bus stop to pick up a passenger. I was travelling below 60km/h and was about 4 metres away when my vehicle commander told me to slow down and get ready to change to the right lane. I noticed and began to slow down to avoid collision. As I was slowing down, I realised that I was going to hit the car despite the deceleration, and to try to avoid it I started to
