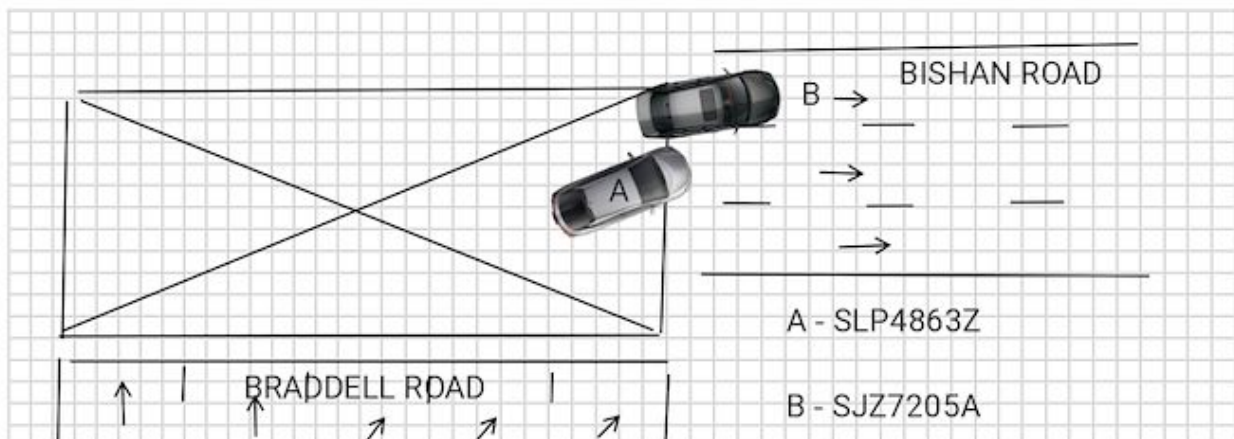

**Sketch Plan**




## Describe Circumstances of the Accident
