Brief Details.

On the 29/3/2023 at about 0900hrs, I was driving my vehicle (JRB2603, vehicle A) along Mandai Rd towards Singapore Zoo on the first lane. I had a passenger with me, namely Lau Sin Lee, seated on the left front passenger seat. I came to a stop at the traffic light junction as it was a red light. Suddenly, I felt a bang from the rear. I then came down from the vehicle and saw that there was a chain collision involving my vehicle, SHC7135M (vehicle B), SJN5642Y, (vehicle C), SKR3097B, (vehicle D). We asked the other drivers if they were ok and vehicle B's driver called the ambulance. I then got to know that vehicle D collided onto the rear of vehicle C and the impact caused vehicle C to collide onto the rear of vehicle B, which resulted in vehicle B colliding onto the rear of my vehicle.

Subsequently, traffic police and ambulance came and interviewed us. Nobody was conveyed to the hospital.

I went to see a doctor at K.L. Tay Clinic & Surgery and I got a 2 days MC as my neck was in pain from the whiplash due to the accident.

My vehicle's rear bumper is dented and the rear boot cover is also dented.
