

Hi, I would like to report the above incident asap.

This incident happened at around 11pm at 644 hougang ave 8 carpark.

I am the driver of the incident. No injuries, no damage to my vehicle, minor scratches on incidental vehicle.

Gist of what happened:

The weather is clear, area well lighted. Incident happened at around 11pm in carpark along blk644 hougang ave 8. It is a straight road with parking lots on the side. when I was inching out from my lot, my head is already more than half over the road already, the incident car, SMP1034H, sped over more than the designated car park speed limit and scratched the side of his car against my bumper (no damage to my bumper). Due to the blindspot I am in (there is another van beside my parked vehicle), I could not see him coming when the accident happened. Im in a very slow speed if not the impact of the accident would have been dire. The driver failed to see that I have already inched out more than halfway through the road and is driving at a relatively fast speed despite in a carpark; As such his response is slowed. As seen on the photo, I have already more than halfway inch out from the road so he should have been able to see me from far.

I will be going down to the reporting centre to report asap tho there is no damage on my side.

(I tried to report on the police system but it doesn't seem to be working.)
