Hi Ms Hsiao Tong,Chew,

We refer to your email on above car accident case. Due to the understanding and a clearer picture, we conducted a investigation and interviewed our driver Mr Yacob Bin Awi.

Based on our findings, we argue you that it is not correct a settle the 3rd party claim.

On that day, while coming out of a unit office along Tuas Basin Link, Mr Yacob looked at his right to clear his road before slowly moving his lorry YN4960H forward and slightly turning his lorry wheel towards left as he move towards his left. His lorry is big one and is a 14ft with full cabin enclosure. Because of this, always when starting to move out he will drive slow especially during turning cos of his lorry big capacity.

I want to point out few points here:

1.) The Road along Tuas Basin Link is a one lane one directional road with 2 different direction.
Mr Yacab has turn left first and taken the lane first.
2.) While he may have turned a wider circle cos of the lorry's weight etc, he has the right of the road lane once he is on the road and in front. All vehicle behind will have to wait and follow behind cos it is a one lane one vehicle road. Let's be clear about this first.
3.) As it is very obvious in this case and of no.2 reason, the other driver wanted to move in front of the lorry thinking it was a slow moving lorry and that he speeded his car and cut thought towards his left by way of taking over to the front. This is a fact that is wrong. First, cutting a vehicle in front is always by your right and second this is a one lane vehicle one directional road. It is not for 2 vehicle at same pavement together and it is even so while moving of vehicles.

The actions of the driver SHC2681K is of wrong and endanger others. It is irresponsible and we do not agree to the other party's statement. We hope you understand the situation happened on that day and that revert us the answer.

Kindly note the matter and that proper investigation will be conducted thoroughly.
