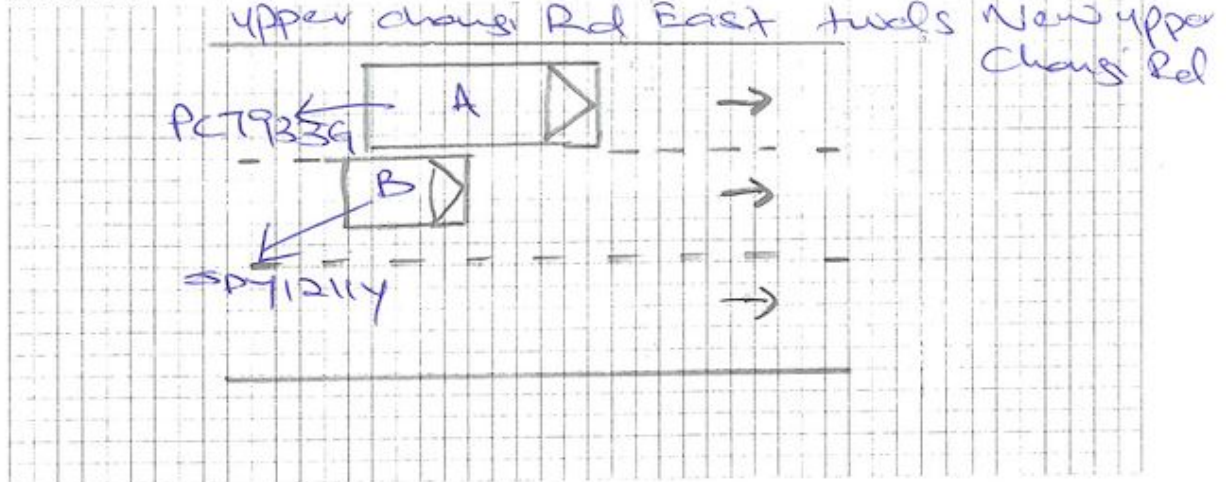

**Brief Details.**

On 27/03/2023 at about 0920hrs, I was driving my company bus (PC7933G) along Upper Changi Road East towards New Upper Changi Road. It is a 3-lane road, and I was driving at the left lane at that point of time. I was driving in a normal speed due to heavy rain. When I was about to make a left turn into Bedok Road, I felt an impact from the right side of my bus. One car (SDY1211Y) hit onto the right side of my bus. I stopped the bus at the roadside and looked through the car behind me from my right window. The driver stopped his car for a while but did not went down from his car and only raised up his hand and looked at me and subsequently he drove away. He is a male Chinese, believed in his 60's. My bus's damages were scratches on the right-side area. In car camera was installed and I had the footage of the incident.
