
I was driving along the carpark road, driving straight, and another vehicle suddenly turned out of its carpark lot and hit the left side of my car. Both cars stopped upon collision.

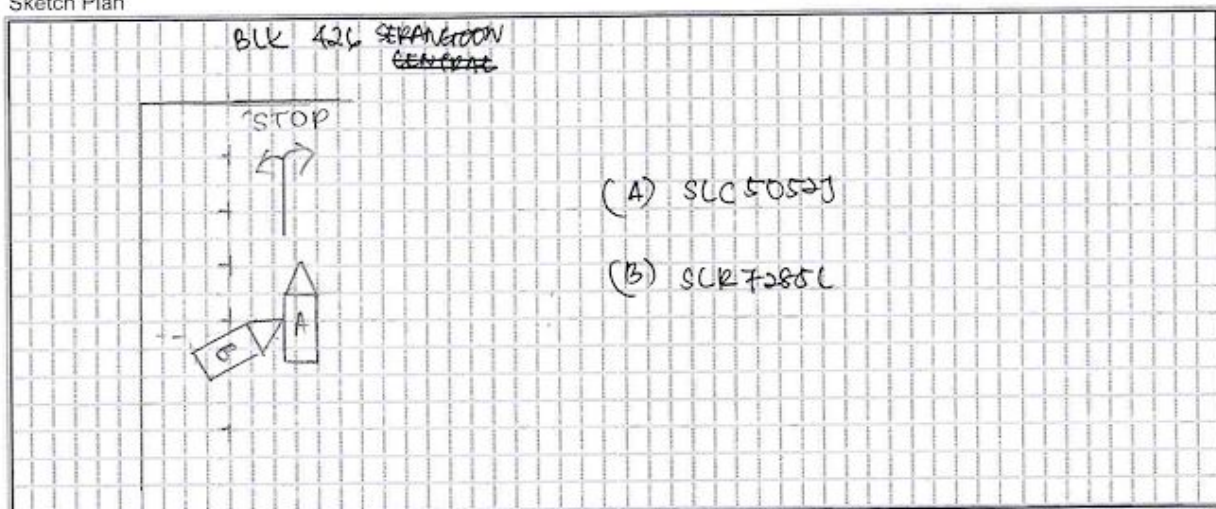


