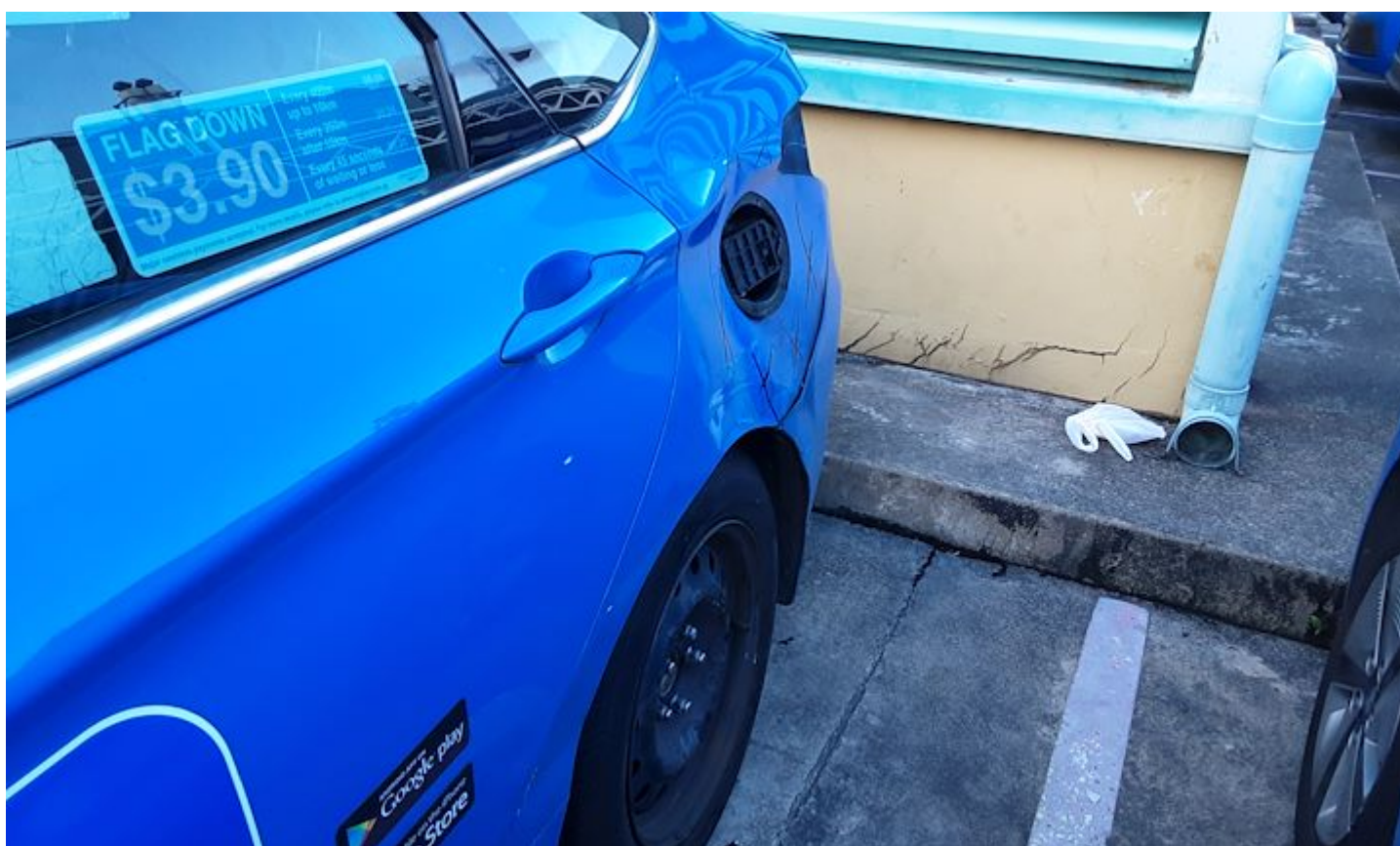

Brief Details.

On 29/03/2023 at about 0215 hrs, I was driving my company taxi (SHA4914L) on the right lane along Ang Mo Kio Avenue 6 turning right towards Ang Mo Kio Avenue 3. I saw that the traffic light was green and began to turn right but as the front of my vehicle began to cross the pedestrian crossing, I felt a strong impact on the left rear of my vehicle near the fuel cap area.

I then alighted and noticed a motorcycle (FBJ9941Z) collided onto my taxi. The rider claimed that his ankle was injured and he went to sit at the corner of the kerb while I called for the ambulance. We then exchanged our particulars and I also made a check on my vehicle while waiting for the ambulance. I noticed that my fuel cap and left rear brake light was damaged from the collision. The ambulance and Traffic Police arrived shortly after to make a check on him and conveyed him to the hospital. The Traffic Police interviewed me and took the memory card from my front in-car camera which was recording at the point of the accident. They also advised me to lodge a Traffic Accident report before I drove off from the scene.

I wish to state that I am not injured from the accident.
