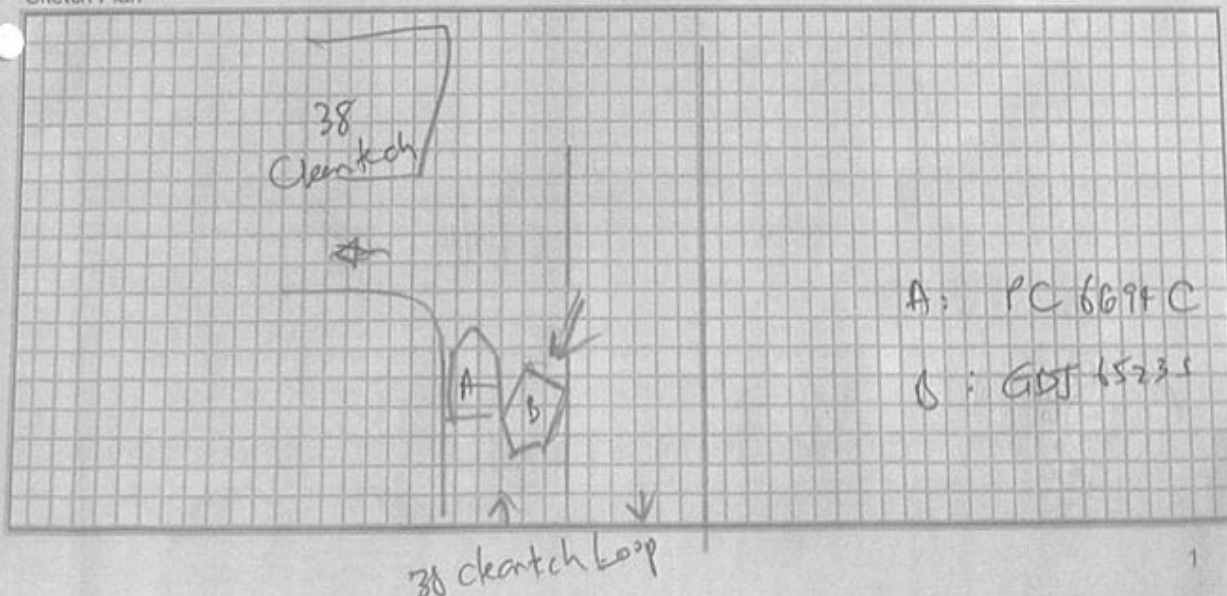

Describe Circumstance of the Accident

On 29/03/2023 at about 1620 hrs, I stopped my van (PC6694C) just before the entrance of the 38 cloveleaf loop.

Subsequently One Vehicle Toyota Hiace van (885 GBJ 65235) from the opposite direction came moving towards the direction of my van without driver and collided onto my stationary vehicle (PC6694C).

The Van driver then told me that he forget to pull his handbrake as such, the van Roll over and collided onto my van.

My Van was ~~seriously~~ seriously damaged. The car sale van driver wasn't injured due to this accident. No government property was damaged. No pedestrian was involved. No foreign vehicles was involved. My in-car camera in my van caught the accident.
