Sketch Plan

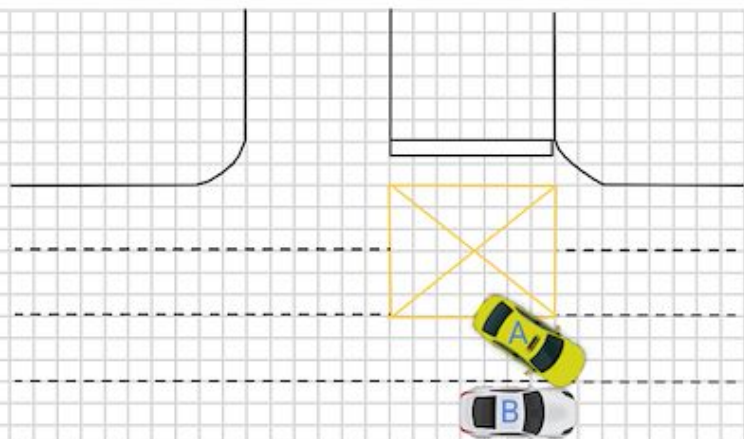
