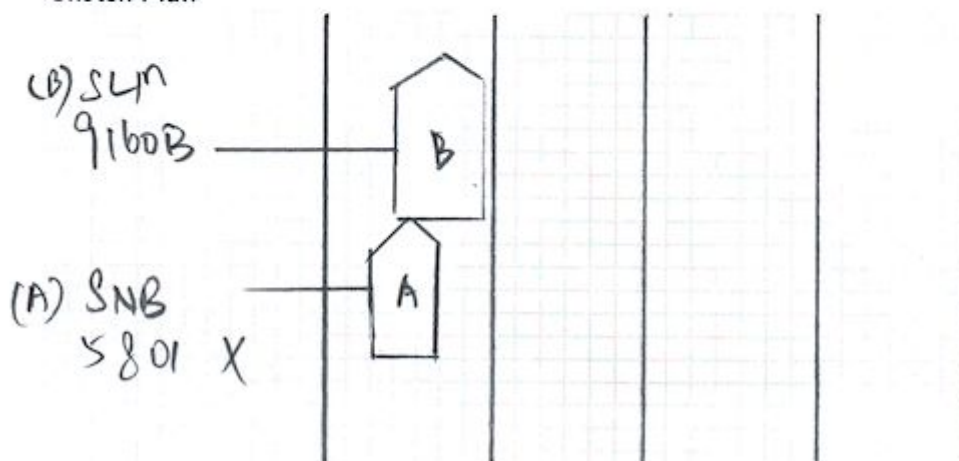

- ii) Without prejudice to the Owner's other rights, the Hirers will be liable to an administrative fee of SGD\$80.00 per week. In addition, a 2 % late fee payment of the Rental charges / Deposit or other payment remain unpaid after becoming due will be computed daily. In the event, the Rental Fee remains unpaid for more than THREE (03) calendar days, the Owner may lodge a police report as a loss of vehicle and activate the vehicle repossession team to retrieve the vehicle. The incidental cost for repossession process of a minimum SGD\$350.00 will be charged to the Hirers. In the event a Debt Collection Agency is engaged to collect all unpaid monies due to us, all such costs will be charged to the Hirers and will be included and calculated as part of the total sum of monies due from the Hirers.
- iii) All payments due hereunder shall be made to the Owner at its address stated herein or at such other address as the Owner may from time to time communicate to the Hirers. - This Agreement will be automatically renewed monthly basis after the expiry of this Vehicle Rental Agreement. The Hirers are deemed to have agreed to continue to rent this Vehicle at the same conditions set out in this Agreement.
- The existing rental rates may be subjected to change. All such changes will be notified to the Hirers either by SMS or any other suitable communication mode which will be deemed made and notified to the Hirers.
- Hirers are liable to pay all rental charges as agreed herewith timely thereafter.
- The Owner reserve their right to terminate this Agreement after the contract expiry (by giving 24 hours' notice without assigning any reason whatsoever).



#### 6. TERMINATION NOTICE

- Hirers **MUST** give a **30 days' notice** by submitting the **TERMINATION FORM**. (please refer Annex 1)
- Hirers **MUST** submit this Termination Form to the office and ensure it is duly acknowledged by the company official representative.
- The 30 days' notice will commence from the day the Termination Form is received and acknowledged by the official representative.
- Failing to provide 30 days' notice will result in the Hirers deposit being forfeited and all remaining overdue rental charges and other related charges to become payable immediately upon demand from the Owner.
- The Owner reserves the right to claim the remaining uncompleted rental duration from the Hirers.
- The deposit paid **CANNOT** be used to offset or contra any remaining unpaid rental charges other related charges.
- The Owner may request the Hirer to return the vehicle at any time after the Termination Form has been submitted with a 3 working day notice. The Owner shall not be liable for any loss incurred directly or indirectly by the Hirer that may arise due to the return of the Vehicle. If the vehicle is not returned within 3 working days, this Termination Form is deemed to be cancelled.
