SKETCH PLAN

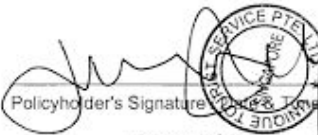

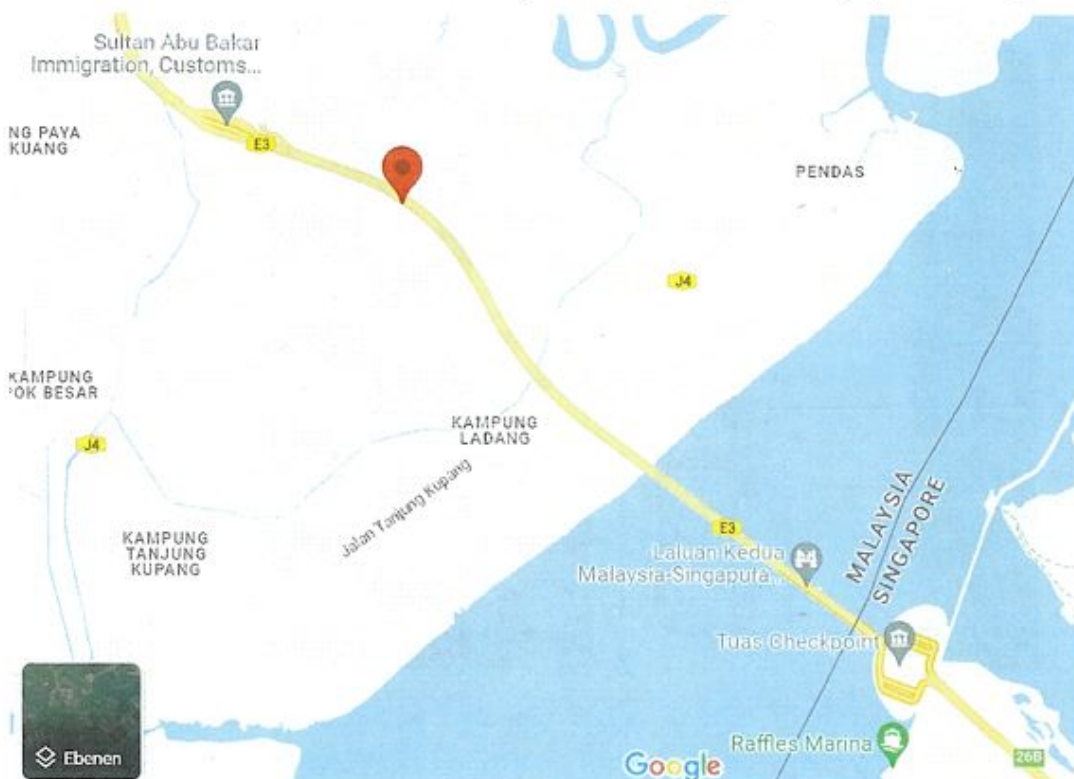

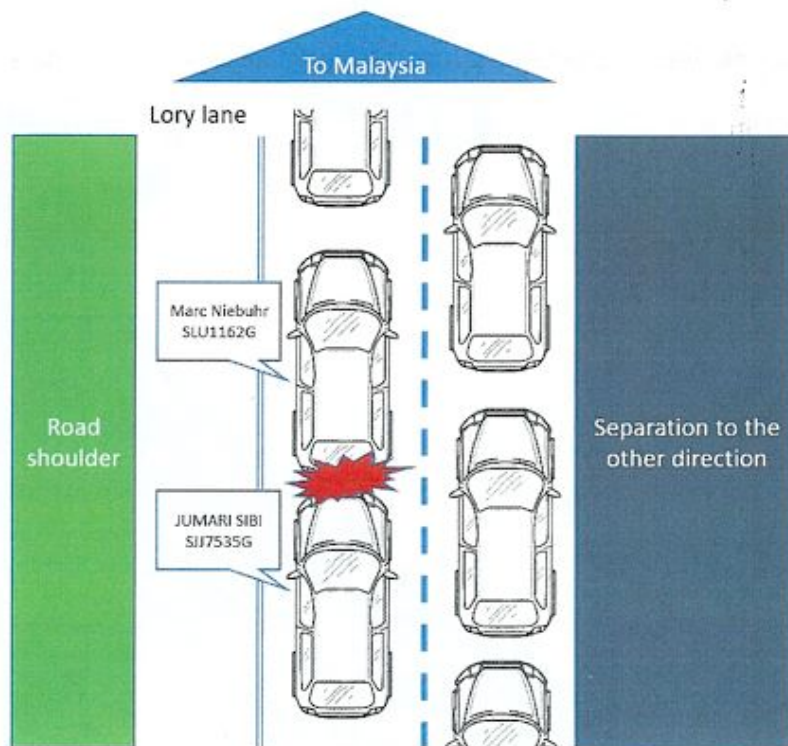


On April 1, 2023, at approximately 13:25, my car with license plate number SLU1162G was involved in an accident with another vehicle with license plate number SJJ7535G, driven by Jumari Sibi. The accident occurred on Second Link Expressway. Both cars were driving from Singapore to Malaysia. The traffic before the Malaysian check point was moving extremely slowly.

During one of the brief movements forward, the other party's car collided with the back of my vehicle at a low speed, causing minor damage to both vehicles. Both vehicles were able to continue to drive. The exact time of the first crash was 13:25.

Unfortunately, the same scenario repeated itself at approximately 14:04, with the other party's car colliding with the back of my car once again. The exact time of the second crash was 14:04. The second crash caused more damages but both vehicles were able to continue to drive.

The license plate number of my client's car is SLU1162G, while the license plate number of the other party's car is SJJ7535G. The name of the driver of the other party is Jumari Sibi.

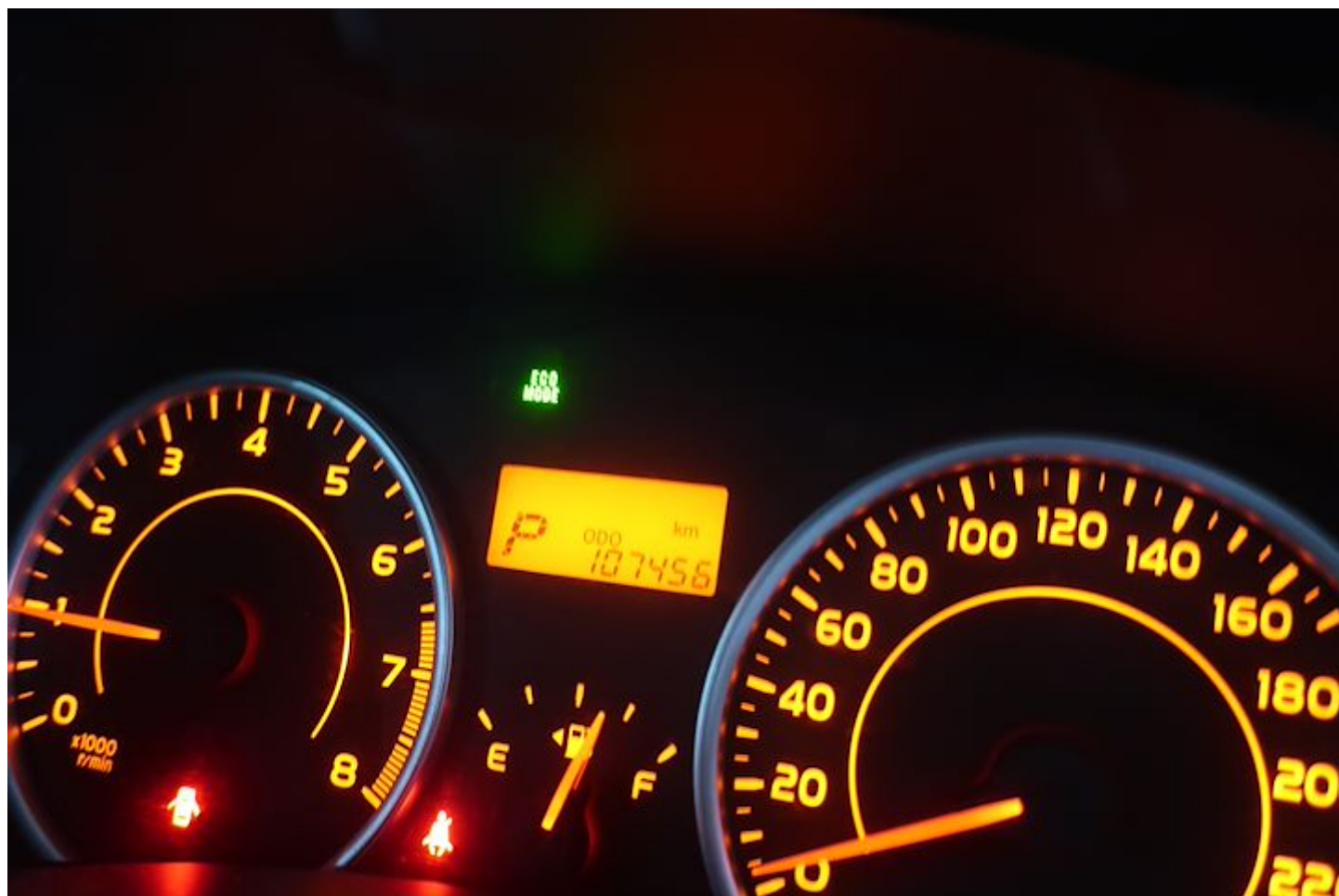


Figure 4: Both cars after accident
