CONTINUATION OF REPORT

Brief Details.

On 2/4/2023 at around 1310hrs, I was driving my company's van along Admiralty Road West towards Admiralty Road. I had stopped at the traffic light junction near Singapore Safety Driving Centre as the traffic light was red. While I was waiting, I felt a strong impact and heard a loud impact sound coming from the rear of my vehicle. When I exited the vehicle to check, I saw a white colored lorry driving off from behind my vehicle. I then managed to catch a glimpse of the driver who was believed to be a male Indian national aged around 27 years to 35 years old. From what I was able to see, I suspected that he was in a drunken state as his eyes were closed, and his head was facing down. I gestured to the driver to stop and come down however he ignored me.

I can recognize the driver if I were to see him again. I sustained pain on my left leg and my neck however I have yet to seek medical treatment. My vehicle's rear portion is badly dented and the two rear windscreens were smashed. That's all.
