Brief Details.

On 03/04/23 at about 1700HRS, I was riding my motorcycle VGM227 along Pickering Street towards Church Street on the right most lane. Suddenly a car SLU1800Z came out from Synagogue Street onto Pickering Street and was heading towards China Street which was on my right side. The car had crossed a double white line. I could not stop in time as I did not see the car initially and I hit the front right side of the car. I then fell on my right side. I moved to the side of the road soon after. The driver moved her car to the side before checking on me.

About 20 minutes later, the ambulance were at scene followed by Traffic Police. The paramedics informed me that I did not have to be conveyed. Traffic Police took the SD card of the in-car camera recording of the car and informed me to go to a hospital and to make a police report. There were no pedestrians involved. There were no passengers on both vehicles. The driver was not injured at the time of incident. I went to Khoo Teck Puat Hospital after the incident and was given a medical certificate ref: 1398451257, 3 days of outpatient sick leave from 04/04/2023 to 06/04/2023. I was in the emergency department from 03/04/2023 2030HRS to 04/04/2023 0014HRS. The doctor informed me that my injuries were a neck sprain, swollen back and waist, and abrasion at my right knee, elbow, shoulder, and arm.

My motorcycle fork, handlebar, key and box rack were bent out of place. My right side mirror, front and right coversets were scratched. My right footpeg, basket and left signal light were broken. The car was damaged at it's right side. The bumper was knocked out of place and there were scratches on the rim and bumper. That is all.
