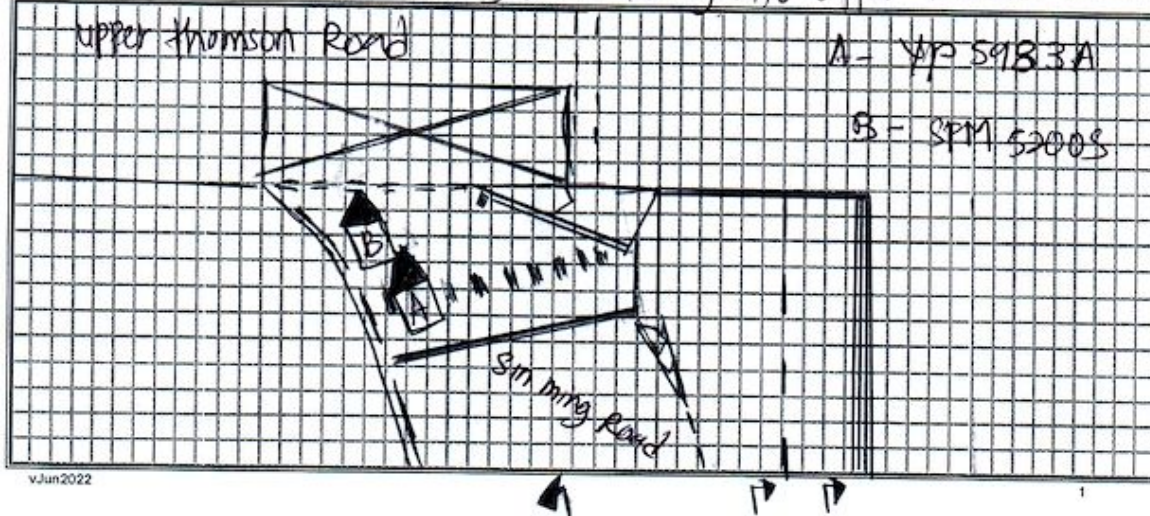

Describe Circumstance of the Accident

I was traveling along Sin ming road after my delivery, moving to another delivery at Thomson Road area. At the traffic and zebra crossing of the junction of Sin ming road and upper Thomson road, the traffic light was red, and pedestrians were crossing the road. After the zebra crossing, vehicle B suddenly jam Brake but there was no people or car moving out since the traffic light was red. Causing a collision on my vehicle because of the heavy load I have in my lorry, about 160 bags of ice. There is no reason for vehicle B to jam Brake. There was a post damage on the rear bumper of vehicle B, that damage was not caused by my vehicle.
